The intent is to preclude unauthorized vehicles or pedestrians from gaining access to the movement area. The only time multiple vehicles should pass through a gate is if you are actively escorting someone on the airport.

Hangar Usage & Storage

Hangars are to be used exclusively for the storage of an aircraft, tools, and other items needed to maintain the aircraft. However, certain actions are restricted or prohibited by City Code and NFPA Fire Code. The list below are items that are not authorized in hangars and the code that governs each:

- Storage of flammable materials outside of fire cabinets (NFPA 407)
- Painting of aircraft or aircraft parts (NFPA 409)
- Non-aeronautical/ personal storage (No more than 15% of hangar can be used for Non-aeronautical storage)
- Trailers, including watercraft, can be stored inside hangars; however, they cannot impede the ingress and egress of aircraft to that hangar. (City of Fort Worth Code)
