

- Partnership with Trinity Habitat for Humanity since 2011 providing volunteers; agency has had primary program control since 2017
 - Habitat supplies volunteers, paint, and supplies
 - · Retains general contractor to prepare and prime the homes
- Two events per year (Spring April/Fall October)
 - Target marketing in older neighborhoods
 - 2021 Events April 10/October 2
- Available for homeowners earning at or below 50% AMI
