# **Sycamore Park Public Art Project Outline**



Sycamore Park South

The City of Fort Worth is beginning construction in Sycamore Park located in east Fort Worth in Council District 8. The park master plan combines the former golf course and park to allow for repurposing opportunities and amenities that will better serve the community. Sycamore Park, one of the oldest parks in the city, spans 94 acres and contains several athletic fields, including the home stadium of Texas Wesleyan Rams Softball and Baseball and the Vaquero soccer team turf field. Construction of Phase 1 park improvements has commenced in the south tip of the park along Vickery Boulevard, and includes a realigned loop road on Sycamore Circle, a new parking lot, pedestrian trail, playground, and other amenities. Completion of construction is scheduled for March 2023?.

#### **PUBLIC ART BUDGET**

The Public Art Plan for the 2018 Bond Program, Proposition A, designated \$337,500 in 2% public art funds (including contingency) for the Sycamore Park Roads Project. The project was included in the Fort Worth Public Art Fiscal Year 2022 Annual Work Plan and Budget, adopted by the Fort Worth City Council on November 6, 2018 (M&C G-19412).

## **PUBLIC ART SITE AND APPROACH**

This public art project provides an opportunity for an artist to create an engaging and educational artwork in the south area of the park, adjacent to East Vickery Boulevard, where it would be easily accessible, highly visible and have the greatest impact. The opportunities for an artwork include a freestanding or integrated artwork for the pedestrian trail, the entrance sign or the pedestrian crosswalk connecting the north and south sections of the park along Vickery Boulevard. On August 2, 2022, the Project Core Team discussed their desire for artwork that might speak to the history of the surrounding area and provide an opportunity for visitors of all ages to engage.

#### **ARTIST SELECTION PROCESS**

## **SELECTION PANEL MEETING #1**

FWPA staff shall present a pool of 6-8 artists from the Fort Worth Public Art Pre-Qualified List of Artists, whose work would be a good fit for the project for consideration by the Artist Selection Panel. Artists will be contacted prior to being considered, to ascertain their interest and availability. The Artist Selection Panel shall review the artists' qualifications and select three (3) finalists and one (1) alternate.

#### **FINALIST ORIENTATION**

The finalists shall participate in an orientation on site, if possible, prior to Selection Panel Meeting #2 to be further familiarized with contextual surroundings. The Artist Selection Panel and Project Core Team shall be invited to participate in the orientation.

## **SELECTION PANEL MEETING #2**

The Artist Selection Panel shall interview the three (3) finalists individually at this meeting and will be asked to address a series of questions about how they would approach the project and/or about their professional experience. After discussion, the panel will then recommend one (1) artist and one (1) alternate for the project. Upon the FWAC's approval of the Panel's recommendation, a preliminary design contract will be executed with the selected artist.


Art Commission approved Project Outline on August 12, 2019

- Art Commission approved Artist Selection Panel's recommendation of Artist Gordon Huether on February 10, 2020
- Gordon Huether + Partners, Inc. entered into a Preliminary Design Contract on April 24, 2020 (CSC# 53841)
- Huether met with the Project Core Team virtually on June 17, 2020
- Huether completed a virtual micro-residency with the Fort Worth Police Department (FWPD) during the summer of 2020, meeting with personnel at various ranks to get a sense of Fort Worth and FWPD's role in the community
- Action Item to approve the Preliminary Design was posted on the Fort Worth Art Commission's agenda of November 16, 2020; however, after discussion the Art Commission decided to postpone action to their next meeting
- Action Item to approve Preliminary Design was considered by the Fort Worth Art Commission at the December 14,
   2020 meeting; however, after discussion the Art Commission voted not to approve the design.
- In accordance with the contract, the City of Fort Worth requested the artist to revise the Preliminary Design and, prior to that, meet with City Staff, Chairman of the Art Commission, and the Chief of Police to receive input. Huether met with the group on June 7, 2021 and again on July 12, 2021
- Art Commission approved Revised Preliminary Design on July 19, 2021
- Gordon Huether + Partners, Inc. entered into a Final Design and Commission Contract on May 2, 2022 (CSC# 57496)


#### **NEXT STEP**



#### APPROVED PRELIMINARY DESIGN



During Gordon Huether's micro-residency, he learned that one of the officers' main goals is to be recognized as members of the community. To support that goal the Fort Worth Police Department is actively working to strengthen its relationship to the community.

This work is entitled *Vision*, a name which evokes the ideas of clarity, transparency, awareness and reflection that are essential to effective police enforcement today. This concept utilizes a unique, nonthreatening "basket" that lifts the sphere from the sculpture's base and holds it aloft. The basket will be fabricated from steel plates with a blue finish which will be spaced around the base of the sphere to create the illusion of buoyancy and obscure the support structure beneath. The mirrored-finished stainless steel sphere remains as an eye catching and timeless representation and reflection of the entire Forth Worth community and the people who serve it. The concepts of dignity and honor remain inherent to this installation and are expressed in a modern, bold and iconic manner that will engage and excite viewers.

The Final Design may be presented by artist Gordon Huether during the Art Commission Meeting.

## Las Vegas Trail Roundabout Public Art Project

- On May 17, 2021 the FWAC approved the Selection Panel's recommendation of Mark Reigelman for the Las Vegas Trail Roundabout public art project
- On September 20, 2021, Mark Reigelman was placed under a Preliminary Design Agreement (City Secretary Contract No. 56344)
- On February 17, 2022 the artist met with the Core Team, City's design consultant and City staff for input prior to beginning design

#### Preliminary Design

Mark Reigelman's artwork for the Las Vegas Trail Roundabout, entitled *Right Turn Only*, is a vortex where condensed traffic arrows spiral in on themselves and twirl upward toward the sky. Drawing upon the roundabout's cyclical motion the playful artwork nods to the directional signage that will be part of the roundabout. It also respectfully acknowledges the rich aeronautical history found in the community, by referencing the circular air patterns that are generated by the wingtips of ascending airplanes. The overall spiraling form acts as a traditional symbol of growth, rebirth and ascension. Comprised of hundreds of bright blue steel and aluminum arrows, the artwork gracefully touches the roundabout and extends upwards 20 feet, a bold and whimsical landmark for this re-emerging community.

## **PURPOSE**

In accordance with City Code, funds for public art are included in general obligation bond programs. The City Council adopted *Fort Worth Public Art Master Plan Update* of 2017, states that within each bond proposition, the Art Commission is to recommend a public art plan for each bond program which identifies specific projects to include a public art component and establishes a budget for each. Once adopted by City Council, the bond program public art plan guides Fort Worth Public Art program multi-year and annual work plans and may be amended, as needed.


