## APPROVAL OF MINUTES

Aimee Hancock addressed her concerns to MCPD regarding her numerous accommodation requests to the apartment management due to her disability. Chair Wiley informed Ms. Hancock that Mr. Henderson or staff will contact her to obtain additional information.

Marsha Godeaux, Architectural Barriers, Program Specialist for Tx. Dept. of Licensing and Regulation gave a presentation on Texas Accessibility Standard vs ADA. The floor was open to questions.

## Standing Sub-Committees Reports Review ~ Committee Chairs

<u>Accessibility Sub-Committee</u>: Ms. Henderson reported that they are scheduled to meet next week. Chair Wiley stated that Mike Wyss, Al Henderson, Christina Brooks, and herself attended the new City Hall Chambers groundbreaking and were pleased to see a very specified area for those with disabilities. Mike Wyss attended the IDD Awards and represented MCPD.
