Assistant Director's Report ~ Angela Rush, Assistant Diversity & Inclusion Director Ms. Rush reported the following upcoming events and organization updates:

- 2022 Bond election and thirteen proposed amendments to the City Charter. Both items will be on the May 7 ballot. The three meetings are:

- April 23, from 10 am to Noon, Handley Meadowbrook Community Center, 6201 Beaty Street
- April 25, from 6-8 pm, Rockwood Park Golf Clubhouse, 1851 Jacksboro Hwy.
- The comment period is open for the Mobility 2045 update until May 31. Mobility 2045 is a multimodal blueprint of transportation system improvements scheduled through 2045 in the Dallas-Fort Worth region. To view the Mobility 2045 plan, go to the North Central Texas Council of Government's website at netcog.org, click on Transportation then Plan, Studies, and Reports.
- The enforcement division has been seeing an increase in housing complaints, and since the last MCPD meeting, a housing complaint based on disability settled for more than \$10,000. The housing complaint involved denial of reserved parking space for a resident with a mobility-related disability. The Respondent(s) stated that they don't offer reserved spaces for anyone, which is a violation of the Fair Housing Act in regards to requests for reasonable accommodations.

Mr. Henderson will email the Assistant Director's Report to the MCPD.
