PUBLIC NOTICE OF A MEETING AT WHICH THE FORT WORTH CITY
COUNCIL WILL CONSIDER APPROVAL OF A TAX ABATEMENT
AGREEMENT**

Pursuant to Section 312.207 of the Texas Tax Code, notice is hereby given that the City Council of the City of Fort Worth ("City") will consider approval of a tax abatement agreement at a regularly-scheduled meeting.

Time and Place of the Meeting: The City Council will consider the tax abatement agreement at its regularly-scheduled meeting, beginning at 6:00 p.m. on March 29, 2022 at the City Council Chamber, City Hall, 200 Texas Street, Fort Worth, Texas.

Tax Abatement Agreement Information Required by Texas Tax Code Section 312.207:

1. **Name of the Property Owner and Applicant for the Tax Abatement Agreement:** The name of the property owner is KEITH BROOKS and the applicant for the tax abatement agreement is KEITH BROOKS.
2. **Name and Location of the Reinvestment Zone:** The name of the proposed reinvestment zone in which the property subject to the tax abatement will be located is Neighborhood Empowerment Reinvestment Zone Number 1R ("NERZ 1R"), which was created by the City Council January 29, 2019, prior to consideration of the tax abatement agreement. NERZ 1R is approximately 7.087 square miles and general boundaries are: North: Long Ave., 38th Street, DeRidder Street and Terminal Road; South and Southeast: Bank of the West Fork Trinity River, Grand Avenue and 28th Street; East and Northeast: Decatur Avenue, Blue Mound Road, Ross Avenue, Clinton Avenue, Pearl Avenue, Roosevelt Avenue, McKinley Avenue, Jacksboro Highway, River Oaks Boulevard, Tyra Lane, and Churchill Road; and the West: the Bank of the West Fork Trinity River, Rockwood Park Drive, Houston Street, Ellis Avenue, Deen Road, Ray Simon Drive and Webber Street in Fort Worth, Texas, as depicted in Exhibit A, which is attached hereto.
3. **General Description of the Nature of Improvements:** The tax abatement agreement includes improvements consisting of the new construction of a single-family residence of approximately 1,308 square feet to be used as a primary residence for the owner.
4. **Estimated Cost and Address of the Improvements:** The estimated costs of the improvements located at 3020 Gould Avenue, Fort Worth, Texas, are \$185,600.00.

The tax abatement agreement described herein will also appear on the agenda for the City Council meeting scheduled for March 29, 2022. This notice has been given in a manner required by the Texas Open Meetings Act at least 30 days before the scheduled time of the City Council meeting described in this notice.


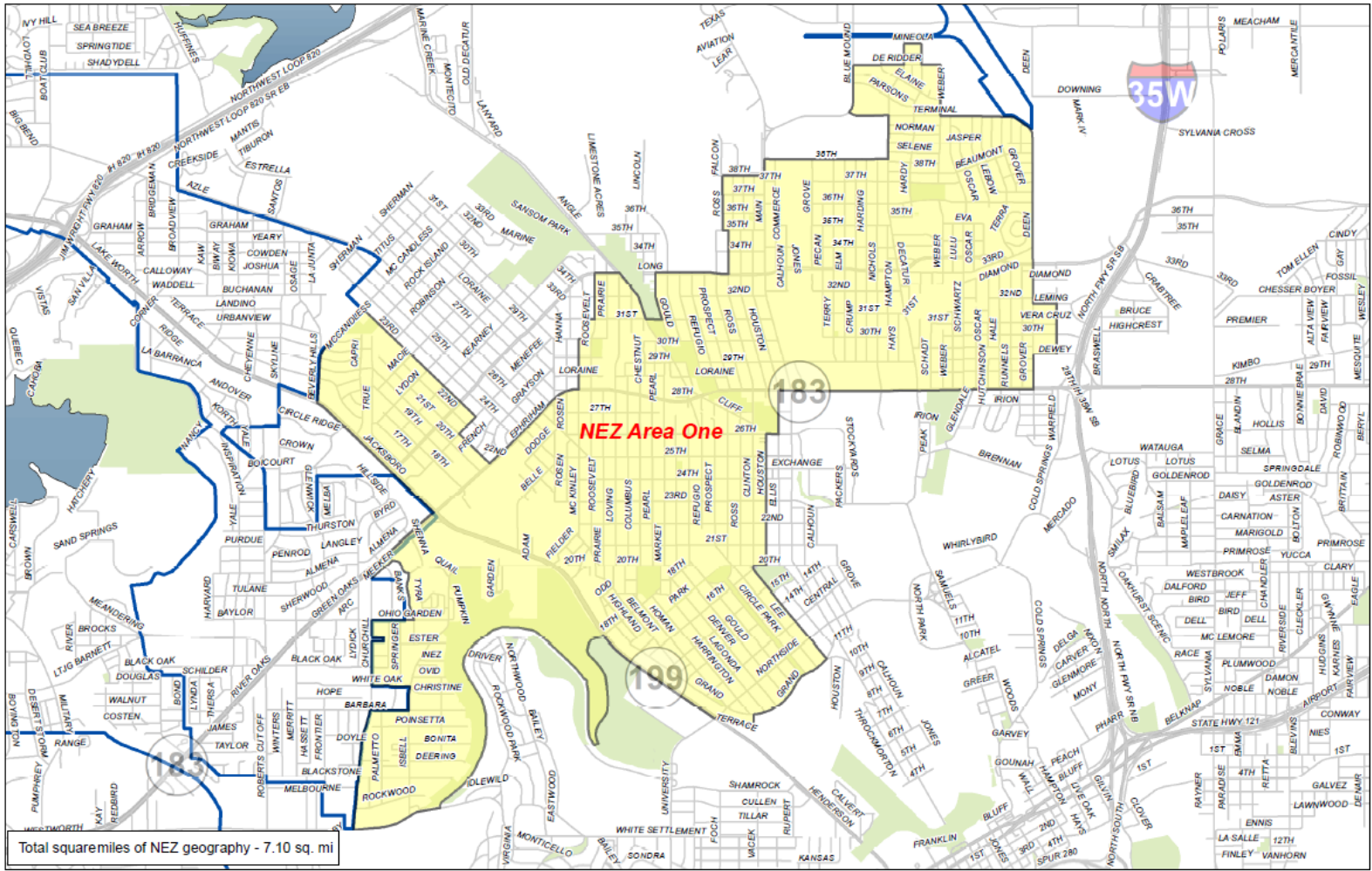
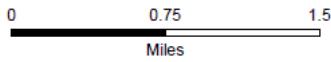
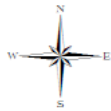
