Bonnie Brae (100198) to SH121 Public Art and Landscaping Project (c01639)

Justification for additional funding of SH121 Public Art and Landscaping Project:

The unexpected change of site from Interstate 30 to State Highway 121 as required by TxDOT required a substantial redesign of the project, utilizing City funds originally set aside to cover various soft costs during construction. The construction phase will require additional funds for:

- City inspection and materials testing
- Design team construction oversight
- City staff project management costs (increased from original projections)
- Construction contingency and cost inflation

It is anticipated that reallocation of the Bonnie Brae funds would make implementation of the artist's vision for the project feasible; however, some value engineering may be required once bids are received.



SH121 Public Art and Landscaping Project – Final Design

Artwork Site

The site is on the north right-of-way median of westbound State Highway 121 (situated west of Maxine Street and east of Beach Street) and just inside the Fort Worth City limits. It offers dramatic views of the downtown Fort Worth skyline.



Narrative Description

Corten steel letters, 10 feet in height, line up to spell out "Fort Worth." A linear pattern of Acme Brick pavers installed at ground-level refers to the "Old Road to the West", inter-planted with TxDOT native wildflower and grasses seed mixtures. The letters will be lit at night. [Note: Artists' rendering indicates a residential area north of the site in the background.]

Justification for Additional Funding of Stop Six Project:

The Fort Worth Art Commission (FWAC) approved the artist's final design on April 19, 2021; however, the artist's fabricator immediately withdrew from the project due to large cost increases in labor, materials, and transportation brought on by the COVID-19 pandemic.

The artist scaled back the project scope in 2021 to fit the available budget at the time. In 2022, a highly qualified and experienced fabricator was identified, but continued cost inflations rendered the remaining project funds insufficient to fabricate, transport and install the project. Additional design revisions would be costly, further impacting the budget and timeline.

It is anticipated that this reallocation of unspecified public art funds would make implementation of the artist's vision for Phase 1 of the project feasible; however, some value engineering may be required.

"Stop Six" (Ramey & Stalcup) Public Art Project – Approved Final Design

Artwork Site


The site for this public art project traffic is the traffic triangle formed by Ramey Avenue and Stalcup Road, block 5437-5427 of Stalcup Road, 76112, in the Stop Six community.

Narrative Description


Fort Worth artist Sedrick Huckaby's design for the artwork is titled, *The Last Train*. The traffic triangle at Ramey and Stalcup in the Stop Six neighborhood will be transformed into a place to gather. The artwork commemorates the history of the neighborhood as the sixth stop of the interurban rail system between Fort Worth and Dallas.

In the center of the space there will be a sculpture inspired by an interurban train car, sitting on a simulated train track. Figures – ambiguous portraits of members of the community – will be painted by the artist on the exterior of the train. The train will be the centerpiece of the welcoming plaza, a coppery "dazzling, shimmering wonder." The artist intends the train to symbolize a spiritual chariot that has arrived to take earthly citizens to a heavenly place.

Project Information

In May 2021, Legge Lewis Legge, LLC – a collaborative studio with extensive public art planning and project experience - was selected to develop a public art master plan for Heritage and Paddock Parks that identifies (1) Thematic approaches for public art elements that reveal the cultural history of the site; (2) Locations and types of public art; and (3) Opportunities for diverse local artists. To develop the master plan, LLL, interviewed diverse groups of community stakeholders and subject matter experts to learn the history of the site, located near the confluence of the West and Clear Forks of the Trinity River, and its complex and layered multi-cultural history. The master plan identifies five (5) sites for various types of public art – both permanent and temporary, including iconic, interactive, light-based. City Council recent adopted of the *Public Art Plan for the 2022 Bond Program*, which sets aside \$1,330,500 to commission permanent artworks at Heritage Park and Paddock Park.(https://fwpublicart.org/wp-content/uploads/2023/02/HP PublicArtMasterPlan FINAL 021723 PDFweb.pdf)



FINAL DESIGN PREVIEW



Merge Conceptual Design's Claudia Reisenberger has developed an uplifting, playful experience for the underpass at North Beach Street and Interstate 820. Responding to the Project Core Team's interest in a gateway artwork that is bold and sparks intrigue, Reisenberger has designed a series of bright colored wind wheels that connect to the identity of the area and greater Fort Worth.

For the Final Design, fifty-eight (58) artist-designed wind wheels made of bicycle components will create movement northbound and southbound through the underpass, attaching to the site's colonnades. Reisenberger has developed eight (8) complex wheel designs as well as eight (8) specific colors in various combinations to be dispersed throughout the underpass. Each individual wheel will respond to the environmental elements of the area, specifically wind and light: wind that passes through the site on a given day will push the wheels to spin at various speeds; and, light will illuminate the wheels' reflective surface, allowing tonal color shifts throughout the day.

The artist will share further details during her Final Design presentation at the Fort Worth Art Commission meeting on Monday, March 20, 2023.




SITE MAP

PRELIMINARY DESIGN PREVIEW



In response to the Project Core Team's interest in artwork that acts as a landmark, artist Anitra Blayton has developed a Preliminary Design which will act as a symbol of harmony and positivity for the newly opened Alliance Park. Inspired by the wetland and the patterns of organisms in the environment, including footprints of visitors which become one with the ecosystem, Blayton proposes a larger-than-life hummingbird appearing to drink water. The mirrored stainless steel faceted bird will have a series of six (6) wings on each side: the main wing will be detailed with laser cut shoe treads submitted by community members; the remaining five (5) wings will have an iridescent coating that together mimic the wings' rotation. Including the conical water shape, the sculpture will stand twenty-three feet (23') tall and just over twenty feet (20') at its widest point. The artwork will be placed near the entrance of the park in proximity to the newly constructed sidewalk, making it highly visible to a variety of passersby.

The artist will share further details during her Preliminary Design presentation at the Fort Worth Art Commission meeting on Monday, March 20, 2023.
