SUMMARY

The Fort Worth Botanic Garden (FWBG) is home to 16 artworks accessioned into the *Fort Worth Public Art Legacy Collection* by City Council in 2006. As members of the Fort Worth Public Art (FWPA) Collection they are regularly maintained through FWPA Collection Management initiatives and funding.

On April 17, 2023, Patrick Newman, FWBG CEO & President, presented the *Fort Worth Botanic Garden Master Plan*, as approved by City Council on January 24, 2023, to the Art Commission and stated that some of the artworks will need to be relocated within the garden.

The first artwork being proposed for relocation is *Naiads* (1989) by Glenna Goodacre. Composed of three (3) bronze female figures sited near the entrance to the Garden Center building (pictured below), the artwork was donated in 1993 to the City for the Fort Worth Botanic Garden by members of the Fort Worth Garden Club, and friends and family of Fort Worth native, long-time Garden Club member and philanthropist, Caren C. Koslow, in her memory.

Currently, the FWBG is designing the new Baker Martin Family Garden and raising funds for its construction. The design includes a small body of water which is proposed as the new location for *Naiads* and in keeping with the artist's intent (see following page for the Site Map with proposed general location circled in red).

Since the future expansion of the Garden Center will displace the sculptures, Garden staff recommends relocating *Naiads* in coordination with the construction of the Family Garden so that footings for the sculptures and the "rock" upon which the seated figure is placed can be included in construction documents. The FWBG will cover all costs associated with deinstallation, transportation, engineering and construction of footing, and installation at the new site.

ABOUT THE ARTWORK

Art Castings of Colorado, located in Loveland, Colorado, fabricated *Naiads* as an edition of fifteen (15) sets, with four (4) different figurative sculptures each. The Fort Worth installation of *Naiads* is edition number six (6) and includes just three (3) figurative sculptures. The artist said of the figures: they are "contemporary interpretations of the ancient Roman and Greek mythological nature goddesses in charge of the element of water. These beautiful maidens lived in all springs, rivers, lakes, and fountains, to give them spirit and life."

Currently, the sculptures are sited near the Garden Center entrance where *Runnels*, a modern artist-designed water feature, but are not located near a natural or natural appearing water source. The figures are standing or seated along a stone path in a garden area with trees above and ivy on the ground.

ABOUT THE ARTIST

The sculptures of Lubbock-born Glenna Goodacre (1939 – 2020) are known for their lively expression, texture, design and sense of movement and she sculpted over 600 different works, the most well-known of which is the *Vietnam Women's* Memorial, installed in Washington, D.C. on the National Mall in 1993. Her largest piece is the massive *Irish Memorial*, cast in 2002 for Penn's Landing in Philadelphia. She is also recognized for the obverse of the *Sacagawea U.S. Dollar* first minted in 2000.

An academician of the National Academy of Design in New York and a fellow of the National Sculpture Society, Goodacre career spanned four decades. In 2010, for the 10th anniversary of the Sacagawea Dollar, Goodacre's studies and designs for the coin were added to the Smithsonian National Numismatic Collection in Washington, D.C. In 2013, Goodacre received a Lifetime Achievement Award from the Booth Western Art Museum in Cartersville, Georgia. In 2014 she was awarded the Legacy Award from The Texas Tech University Museum Association in Lubbock*.

Far Northwest Library Public Art Project Outline





The City of Fort Worth is designing and building a new branch library in far northwest Fort Worth. The new building will be located on the south side of Avondale-Haslet Road near the intersection of Austin Stone Drive (Sendera Ranch) in Council District 10.

BACKGROUND

Over half of the City of Fort Worth's library systems are located within the 820 Loop. As the city continues to expand far north, so does the need for additional community and library services in this sector. After the \$1.64 million bond was approved for library improvements, the city acquired three-acres of land in Haslet, Texas for the development of a new library. The project to design and build the Far Northwest Library was included in the city's 2022 Bond Program, and the project scope includes design and construction of an 18,000-square-foot facility, parking lot, and landscaping.

HKS Architects were selected, and the design process is expected to take ten (10) months and construction twelve (12) months, with the project being completed by the first quarter of 2025.

PUBLIC ART SITE AND APPROACH

This public art project provides an opportunity for an artist to create a unique artwork for the new Far Northwest Library. The artwork may be integrated into the interior and/or exterior of the facility, in coordination with the City's consultants; or it may be integrated into the landscape active space around the perimeter of the facility. Representatives of the Fort Worth Library Department noted that the artwork could be located inside or outside of the building and must be accessible to the public. The artwork should be interactive, tactile and encourage visitors to engage with it, similar to the approach taken by the artwork at the Vivian J. Lincoln Library.

Although the opportunities of each site and project are unique, there is a desire on the part of Library staff that the artwork appear as a cohesive part of the building's design. The far north sector is sprawling with new neighborhoods and families. The artwork should also be cognizant of the community's culture and needs.

In commissioning a public art project for the new Far Northwest Library, there is an opportunity to have a lasting impact on multiple generations of residents in this quickly growing part of the City; to enhance the already engaging and educational nature of the library experience; to offer ways for readers of all ages to experience and learn from visual art, and to become a sought after destination —a gem—at the heart of what is a bustling community.

PUBLIC ART BUDGET

The Public Art Plan for the 2022 Bond Program, Proposition C designated \$245,200.00 for the Far Northwest Public Art Project. The project was included in the Fort Worth Public Art Fiscal Year 2023 Annual Work Plan, adopted by City Council on November 29, 2023 (M&C 22-0932).

ARTIST ELIGIBILITY

Staff will recommend 6-8 artists from the Fort Worth Public Art Pre-Qualified Lists of Established Artists, and additional artists by invitation, whose work would be a good fit for the project.

ARTIST SELECTION PANEL MEETING #1

Artists who are presented will be contacted prior to being considered by the Artist Selection Panel, to ascertain their interest and availability. The Artist Selection Panel shall review the artists' qualifications and select 3 finalists and one alternate.

ARTIST SELECTION PANEL MEETING #2

The Artist Selection Panel shall interview each of the three finalists individually. The Panel may then ask questions about their professional experience and related work. The Panel will then recommend one artist and one alternate for the project. Upon the FWAC's approval of the Panel's recommendation, a Preliminary Design or Final Design contract will be executed with the selected artist.

Each year, the Fort Worth Art Commission recommends a public art annual work plan for the upcoming fiscal year to City Council for adoption. The plan includes new projects to be initiated, as well as in-progress projects, based on funding source-specific public art plans previously adopted by City Council (such as the *Public Art Plan for the 2022 Bond Program*), and initiatives recommended in the *Fort Worth Public Art Master Plan Update (2017)*.

On July 17, 2023, the Fort Worth Art Commission endorsed a *Draft Public Art Fiscal Year 2024 Annual Work Plan* for the purpose of gathering public input and set a Public Hearing for their Regular Meeting of August 21, 2023. The Art Commission will also consider comments received via mail or email in advance of the Public Hearing.

WORK PLAN APPROVAL PROCESS

Following the Public Hearing, the Fort Worth Art Commission will consider recommending adoption of the *Public Art Fiscal Year 2024 Annual Work Plan* to City Council. It is anticipated that adoption of the plan will be on the City Council's agenda in September 2023.

Once City Council adopts the *Public Art Fiscal Year 2024 Annual Work Plan*, it will become the scope of work for professional management of the public art program under the annual agreement between the City of Fort Worth and the Arts Council of Fort Worth & Tarrant County, Inc. (d/b/a Arts Fort Worth) anticipated to be authorized by City Council in September 2023.
