
 Utilize data tools and policy evaluation processes for determining equity in municipal service delivery and workforce across City departments to improve the quality of life for ALL residents and city staff.

# Municipal Equity Process





## Developing a Municipal Equity Decision Making Process

- When we make policies equitable and accessible, we take action to ensure that everyone is included in city life.
  - 1. What problem are we trying to solve? Determining whether disparities exist
  - **2.** What does historical research tell us? -- Examining the impact of past decisions on place, people and policy.
  - 3. What does today's data tell us? Analyzing the current state of play and the impact on place, people and policy.
    - 1. Standardize, protect, collect, and track valuable data points for **longitudinal study**
    - 2. Use data to **understand who benefits now** and why
  - 4. What does the past and current landscape tell us we could see in the future?

    Develop predictive scenarios by resource allocation changes.
    - 1. Determine which groups may benefit from changes and why
  - 5. <u>Identify</u> resources, individuals, laws, and institutions that will systemically <u>support</u> <u>new policy</u>
  - **6.** Recommend an equitable, data-driven strategy.
  - 7. <u>Implement</u> a time bound <u>evaluation and analysis</u> of process and policy impact toward strategy goal
