Qualifications	Clear and documented evidence that at least 51% or more is woman-owned controlled and operated. Six months in operation. U.S. citizenship or legal resident alien status. The contribution of capital and/or expertise by the woman business owner must be real and substantial and proportion to the interest owned. The woman business owner shall have the ability to perform in the area of specialty or expertise without reliance on either the finances or resources of a firm that is not owned by a woman. WBCS also screens applicants for certification with the State of Texas as a Historically Underutilized Business (HUB). So, eligible businesses can receive both certifications through the WBCS in one application process. HUB certification coexists with WBENC-Southwest membership.
