QUALIFICATIONS:

- 18-35 YEARS OF AGE (cannot have reached 36th birthday by the date of the entry-level test: Wednesday, January 6, 2021)
- VALID and CURRENT DRIVER'S LICENSE
 - o Required to obtain Class "B" driver's license during training
- HIGH SCHOOL DIPLOMA, GED CERTIFICATE or 12 SEMESTER HOURS from an accredited college
 or university

ADDITIONAL REQUIREMENTS:

- Must live within thirty (30) minutes of a designated report-in station
 - Must be accomplished within six (6) months of employment
- Successfully pass a written test, an aerobic capacity run, a physical assessment test, a background check, a polygraph examination, an interview board and a medical / physical examination.

ADDITIONAL EXAM POINTS:

Additional points up to a maximum of five (5) cumulative points shall be added to a **passing exam** score as follows:

- Military Veteran = Five (5) points with Honorable Discharge, per DD214 Member 4
