**NOTICE AND INSTRUCTIONS TO MINOR  
ALCOHOL-RELATED OFFENSE  
DEFERRED DISPOSITION**

You have entered a plea of **Guilty or No Contest** to an offense related to the possession or consumption of alcohol by a minor. You have been granted deferred disposition on your case. Therefore, your license will **not** be suspended at this time. Your court costs and probation fee must be paid in full by \_\_\_\_\_ .Your probation, **if successfully completed**, will end on \_\_\_\_\_ and result in the dismissal of your citation.

As part of your probation terms, you must not receive another citation for an alcohol-related offense during your period of probation. You have also been ordered to attend a state-certified Alcohol Awareness Course or an alternative form of alcohol education as specified by the court. The community service requirement consists of writing a \_\_\_\_\_ page, typed paper on the dangers of alcohol use by minors. The paper **MUST** be an original work by you alone and should be typed and double spaced using a 12 point type font. You must provide the court a copy of the completed paper and the court copy of a certificate that verifies successful completion of an Alcohol Awareness Course by \_\_\_\_\_ .

**FAILURE TO ABIDE BY THE TERMS OF THE DEFERRED DISPOSITION ORDER WILL RESULT IN THE SUSPENSION OF YOUR DRIVER'S LICENSE OR PERMIT OR DENIAL OF ISSUANCE OF DRIVER'S LICENSE OR PERMIT FOR A PERIOD OF UP TO SIX (6) MONTHS. THE PERIOD OF SUSPENSION BECOMES EFFECTIVE ON THE 11<sup>TH</sup> DAY AFTER YOUR CONVICTION. YOU WILL ALSO RECEIVE WRITTEN NOTICE OF SUSPENSION FROM THE TEXAS DEPARTMENT OF PUBLIC SAFETY. NO FURTHER NOTICE OR REMINDER WILL BE SENT TO YOU BY THE COURT PRIOR TO THE IMPOSITION OF ANY OF THESE PENALTIES FOR YOUR FAILURE TO COMPLY.**
