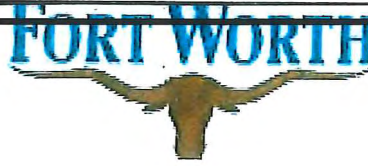

RULES AND REGULATIONS FOR NON-MOTORIZED VEHICLES FOR HIRE

Pursuant to § 34-212 of the City Code, the Director of the Transportation and Public Works Department adopts the following rules:

RULE 1 DESIGNATED AREAS AND TIMES


- (a) A Driver or Licensee providing Non-Motorized Vehicle for Hire Service shall only provide Non-Motorized Vehicle for Hire Service in the following designated areas as defined below:
- (1) *DOWNTOWN AREA* shall mean the area located in downtown Fort Worth bounded on the north by Weatherford Street; bounded on the south by Lancaster Street; bounded on the east by Interstate Highway 35W; and bounded on the West by Henderson Street; excluding 3rd Street between Houston Street and Commerce Street, and excluding 4th Street between Main Street and Commerce Street; such areas being depicted and included in the attached Appendix.
 - (2) *SOUTH SIDE AREA* shall mean the area located in Fort Worth bounded on the north by Interstate Highway 30; bounded on the south by West Berry Street; bounded on the east by Hemphill Street; and bounded on the west by University Drive; such area being depicted and included in the attached Appendix.
 - (3) *STOCKYARDS AREA* shall mean the area located in Fort Worth bounded on the north by NE 28th Street; bounded on the south by Northside Drive; bounded on the east by Interstate Highway 35W; and bounded on the west by Main Street; such area being depicted and included in the attached Appendix.
 - (4) *WEST 7TH STREET AREA* shall mean the area located in Fort Worth bounded on the north by 5th Street; bounded on the south by Interstate Highway 30; bounded on the east by Henderson Street; and bounded on the west by University Drive; such area being depicted and included in the attached Appendix.
- (b) Non-Motorized Vehicle for Hire Service shall only be provided in the *DOWNTOWN AREA*, the *SOUTH SIDE AREA*, the *STOCKYARDS AREA*, and the *WEST 7TH STREET AREA* between the hours of 10:00 a.m. and 3:00 a.m., Monday through Friday and all day on Saturday, Sunday and on the following holidays if the holiday falls on a Monday through Friday: Thanksgiving Day, the Friday after Thanksgiving Day, Christmas Day (December 25), New Year's Day (January 1), Independence Day (July 4), Memorial Day and Labor Day.

RULE 2 AREA AND TIME EXCEPTIONS

- (a) If a Licensee desires to provide Non-Motorized Vehicle for Hire Service in an area or at a time other than permitted in Rule 1, the Licensee shall submit a complete written application to the Director of Transportation and Public Works, or his designee, on a form provided by the Director and obtain written approval from the Director, or his or her designee, no later than 1:00 p.m. on the City business day before the day of the requested service.
- (b) The Director of Transportation and Public Works, or his or her designee, may condition approval on any requirement deemed to be in the interest of public safety, including, but not limited to, requiring the Licensee to have a vehicle escort following the Non-Motorized Vehicle for Hire on major thoroughfares or providing additional temporary lighting on the Non-Motorized Vehicle for Hire.

RULE 3 STANDS

- (a) Non-Motorized Vehicles for Hire shall be authorized to stand in marked designated areas upon the streets of the City. Additional locations may be requested by Licensees for review by the Ground Transportation Coordinator in conjunction with the City's Traffic Engineer and approved by the Director.
- (b) The location of Non-Motorized Vehicle for Hire stands are subject to the control of the Director and subject to change at his or her reasonable discretion. Each stand shall be marked and properly designated under the supervision of the Ground Transportation Coordinator in conjunction with the Traffic Engineer and shall indicate the types of Non-Motorized Vehicles for Hire authorized to use the stand.
- (c) The Director or Ground Transportation Coordinator in conjunction with the Traffic Engineer may establish temporary Non-Motorized Vehicle for Hire stands for special events and functions.
- (d) No Person shall stop or park a Non-Motorized Vehicle for Hire in a stand that the Non-Motorized Vehicle for Hire is not authorized to use as indicated by the signs establishing the stand.

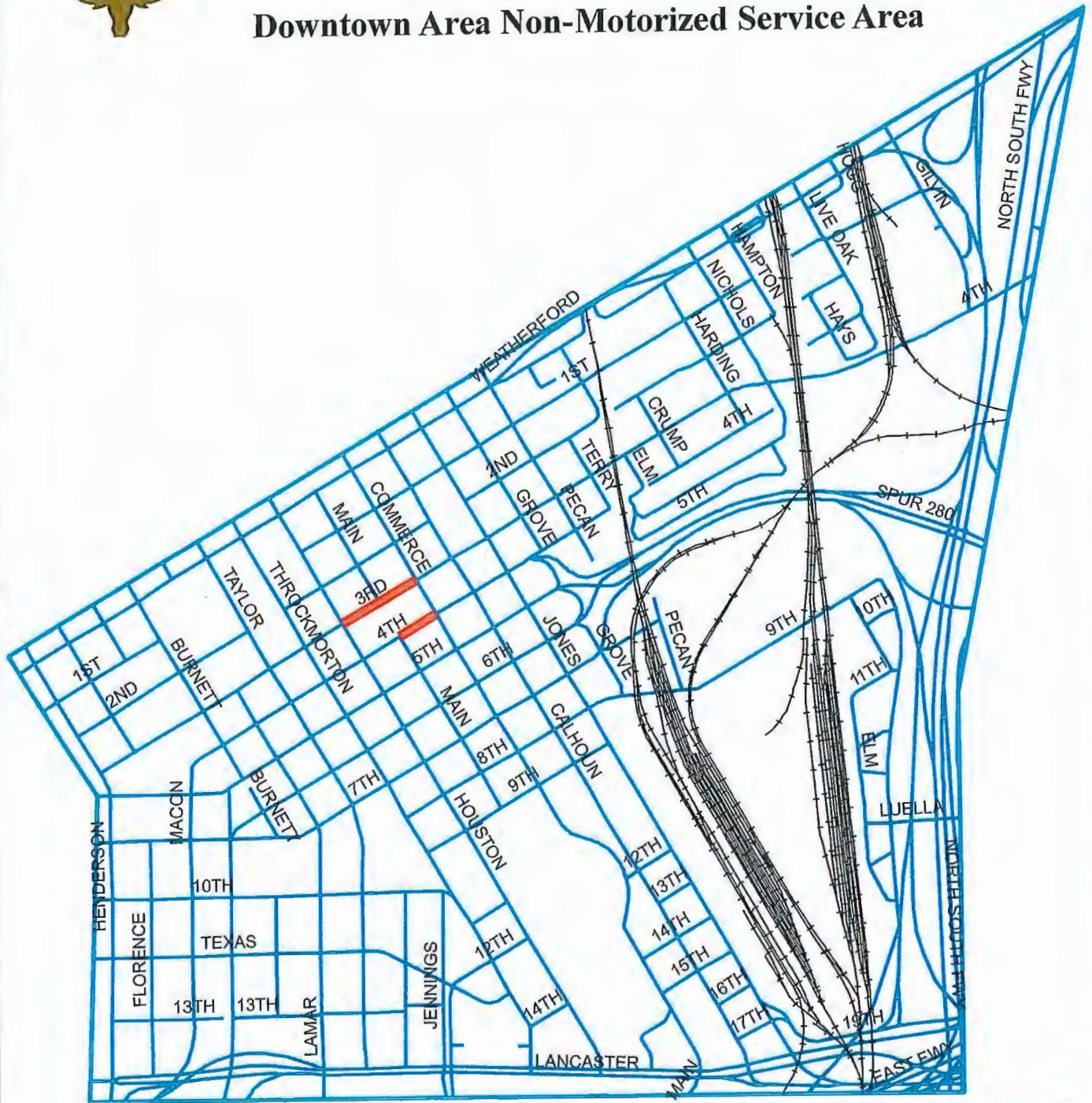

- Non-Motorized Vehicles Prohibited

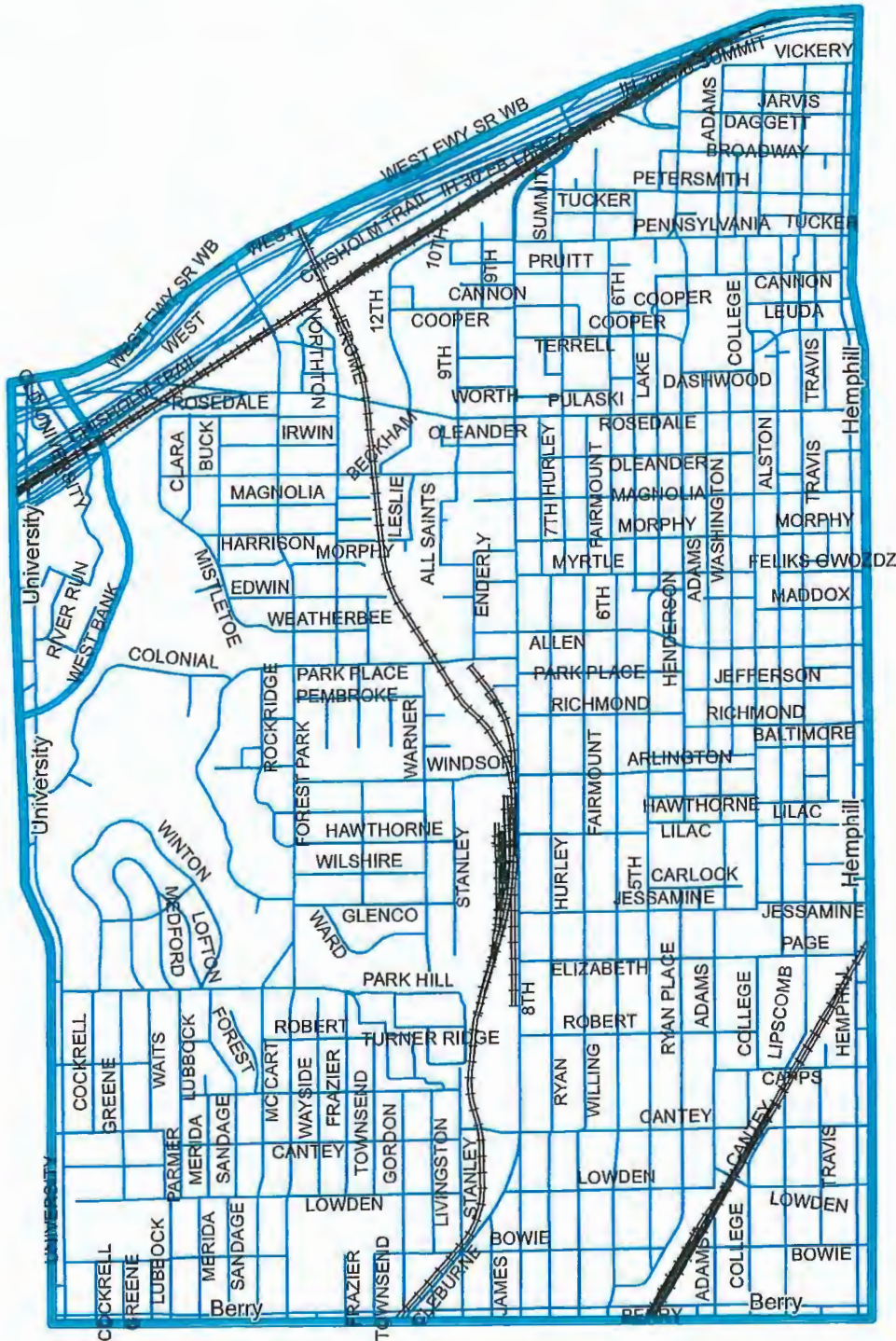

- Riverstream

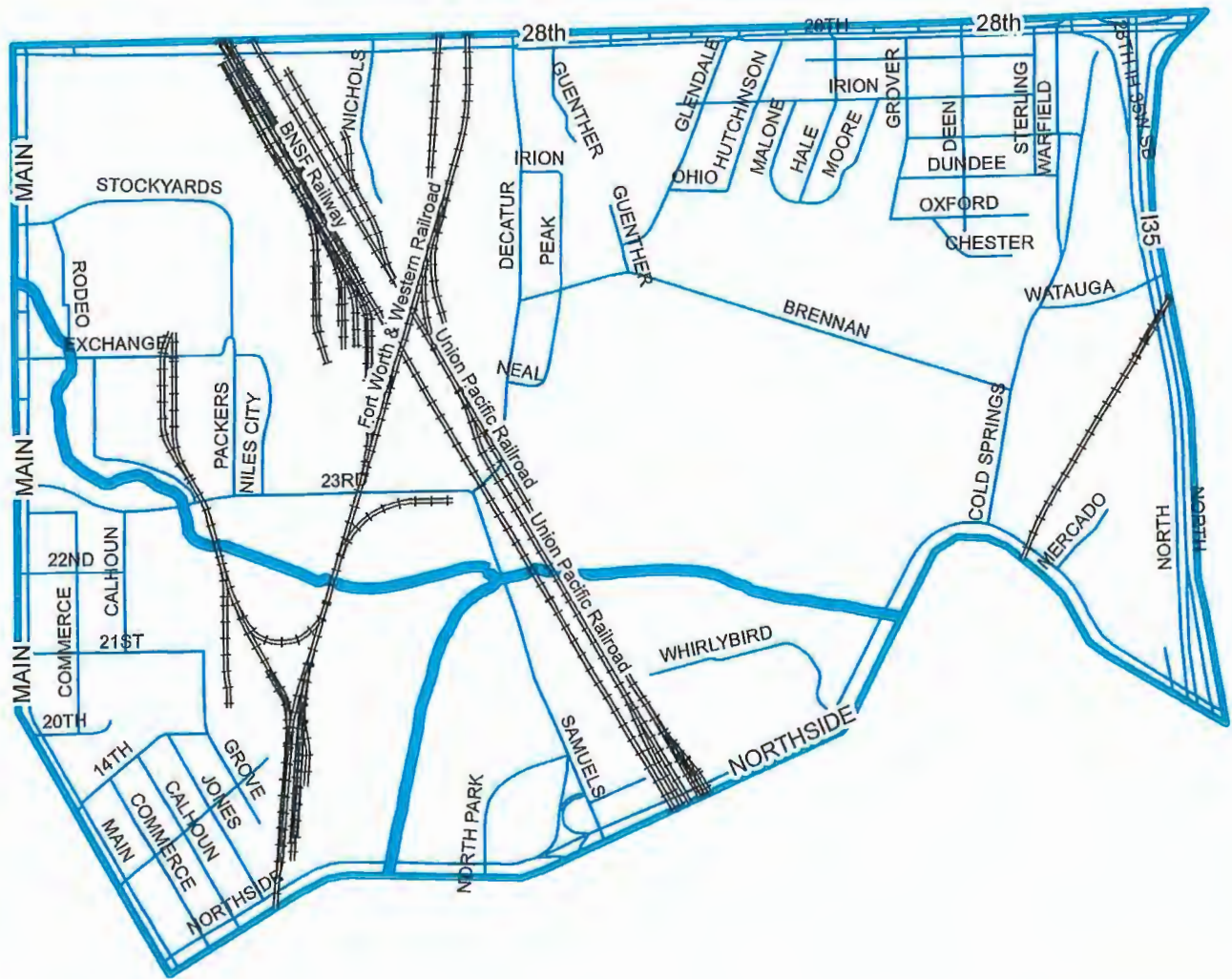

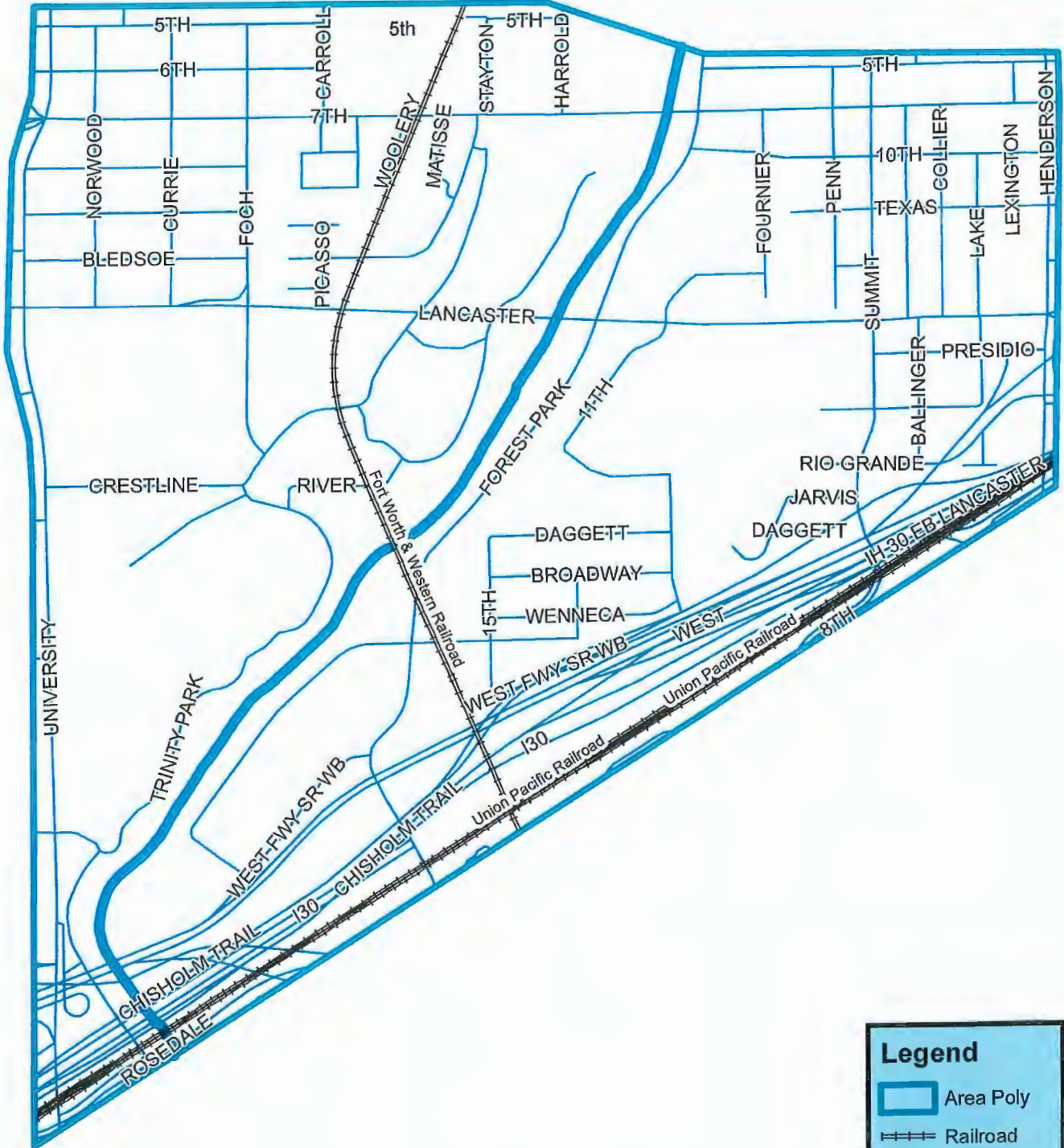
