**1. FS-25-236 – Beach 170 Northeast Corner Lot 1X, Block 1: Waiver Request Section 31-63(e)(6)(a) Street Vacation Recommendation Expiration: 1 Lot, Council District 11.**

Being a 0.835 acre portion of prescriptive right-of-way for Keller Haslet Road, located in the City of Fort Worth, Tarrant County, Texas.

**General Location:** North of Alliance Gateway, west of Alta Vista, and east of Westport Parkway.

**Applicant:** Westwood Professional Services, Inc.

**Recommendation:** Approval of a waiver to Section 31-63 (e)(6)(a) of the Subdivision Ordinance to waive the requirement that a replat application incorporating the northern half of the proposed vacated right-of-way for Keller Haslet Road be submitted within 180 days of the City Plan Commission recommendation to vacate a portion of Keller Haslet Road.

**2. FS-26-008 – Gemini Landing: Waiver Request Section 31-102(b)(2) Interconnectivity of Neighborhoods and Section 31-106(e)(1)(a) Street Design Standards: 1 Lot, Council District 2.**

Being 15.266 acres situated in the David Odum Survey, Abstract No. 1184, located in the City of Fort Worth, Tarrant County, Texas.

**General Location:** North of Meachem Boulevard, south of Great Southwest Parkway, east of Mark IV Parkway, and west of Gemini Place.

**Applicant:** Matt Wright – Foundry Commercial

**Recommendation:** 1) Approval of a waiver to Section 31-102(b)(2) of the Subdivision Ordinance to not require the extension of Saturn Place to the western plat boundary; 2) Approval of a waiver to Section 31-106(e)(1)(a) of the Subdivision Ordinance to not require a cul-de-sac at the termination of Saturn Place; and 3) Conditional approval of the final plat upon meeting the comments in the staff report.

**3. VA-26-001 – Vacation of a Portion of Forest Avenue Right-of-Way Between East Lancaster Avenue and Union Pacific Railroad: Council District 5.**

Being a vacation of a portion of the Forest Avenue right-of-way located south of East Lancaster Avenue and north of Union Pacific Railroad within the Handley Addition, an addition to the City of Fort Worth, Tarrant County, Texas, according to plat recorded in Volume 40, Page 51, of the Plat Records of Tarrant County, Texas.

**General Location:** North of Union Pacific Railroad, south of East Lancaster Avenue, east of Erie Street & west of Handley Drive.

**Applicant:** Dig Contracting - Dante Williams

**Recommendation:** Approval of a recommendation to City Council for the vacation of a portion of Forest Avenue right-of-way.


**DECLARACIÓN DE ACCESIBILIDAD**
