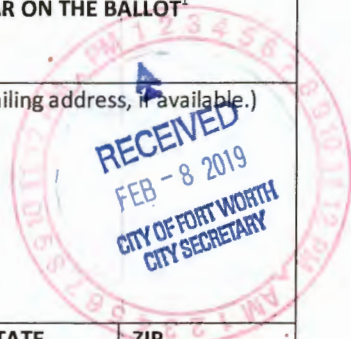

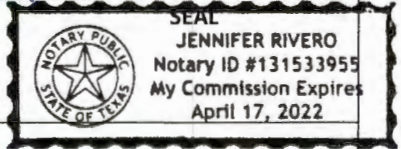
Before me, the undersigned authority, on this day personally appeared (name) Waymond Brown, Sr., who being by me here and now duly sworn, upon oath says:

I am aware of the nepotism law, Chapter 573, Government Code.
