





- Piers are now substantially complete (120 total)
- Superstructure starts in the coming weeks
- Heavy timber delivery in January 2024
- First chamber meetings targeted for Winter 2024-2025

Security and Access Control



The security plan for the new city hall building involves a multi-layered approach that combines:

- Marshal and security team presence
- Advanced camera systems
- State-of-the-art access control systems
- Destination driven elevators
- Weapons detection systems

Through a multitude of deterrents these measures aim to create a secure environment, mitigating safety issues for occupants and protecting sensitive information while instilling operating confidence in the facility.





Security and Access Control

In addition to these key infrastructure items, the City committee on security is working through the following items for final commissioning prior to move in:

- Security staffing and support
- Weapons detection and supporting program
- Staff and public entrance finalization

- Spanish/English signage for key public functions









Building Front (Summit)








Building Monument Signs (5th and Forest Park)







Building Front and South Doors











Parking Expansion and Timing

- After extensive modeling and analysis, garage will expand vertically
- Provides sufficient parking for staff and visitors,
 while retaining the surface lot parking
- Reduces garage downtime, with construction estimated to take 4-5 months (only 30 days of garage closure prior to any occupancy issues)
- Plan will include screening for safety and updates to outdated parking gates
- Estimated completion will be in late Q2/early Q3 2024
