Permitee likewise covenants and agrees to, and does hereby indemnify and hold harmless the City of Fort Worth from against any and all injuries, damage or destruction to the City of Fort Worth property arising out of or in connection with, directly or indirectly, all acts or omissions of Permitee, his officers, agents, servants, employees, contractors, subcontractors, licensees, or invitees of the city of Fort Worth.
