The Public Funds Investment Act (Chapter 2256, Texas Government Code Sec. 225.023) requires that not less than quarterly, the investment officer shall prepare and submit to the governing body of the entity a written report of transactions for all funds for the preceding reporting period.

Attached is the Investment Report for the Quarter Ended March 31, 2020. The report describes current economic trends affecting the City's investments and provides a summary of the City's current investment portfolios. This report contains quarterly reports for the General Investment Portfolio, the Permanent Fund Portfolio, the OPEB Portfolio and the Retirement Fund. 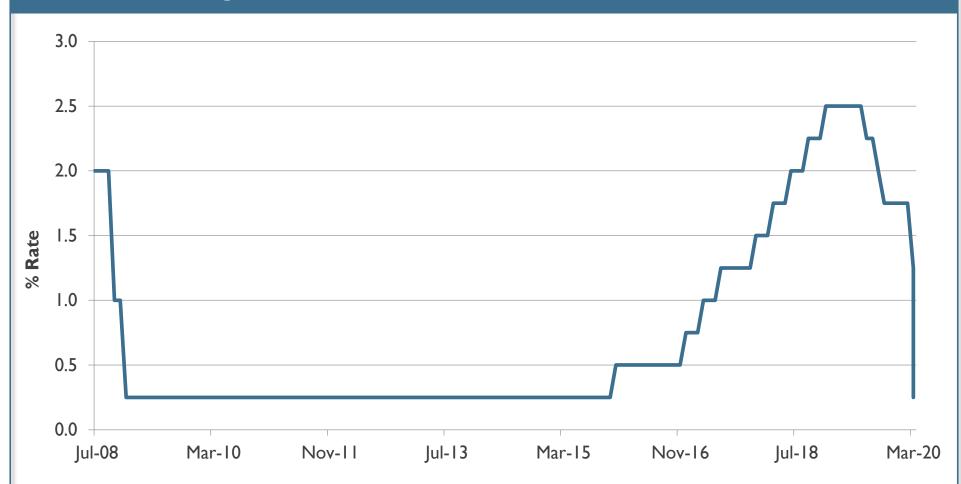

Fed Funds Target Rate



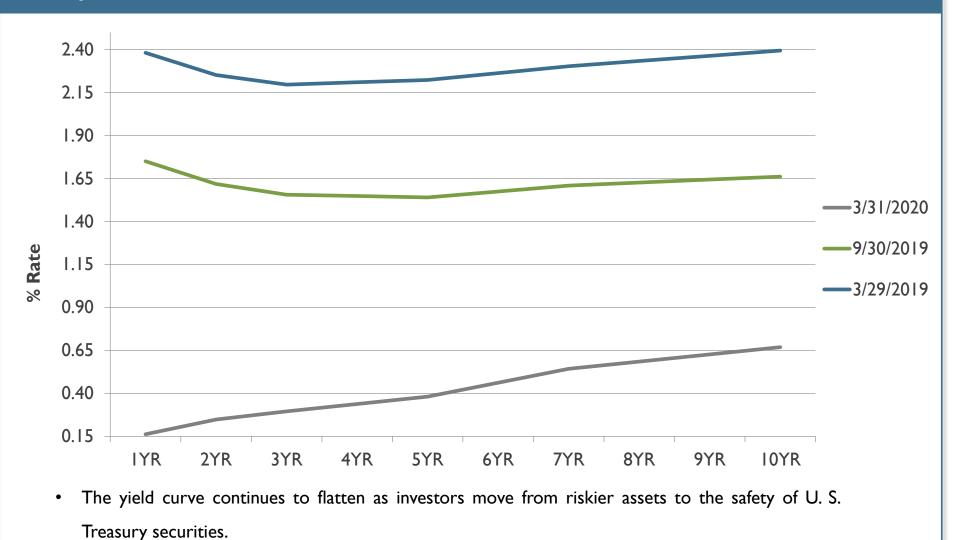
- The Federal Reserve decreased the target rate to a range of 1.00% to 1.25% on March 3, 2020. They announced another 100 basis point cut down to 0.25% on Sunday March 15, in response to the evolving risks presented by COVID-19 to the economy.
- The Federal Reserve has not made a cut like this since late 2008, shortly after the collapse of Lehman Brothers.

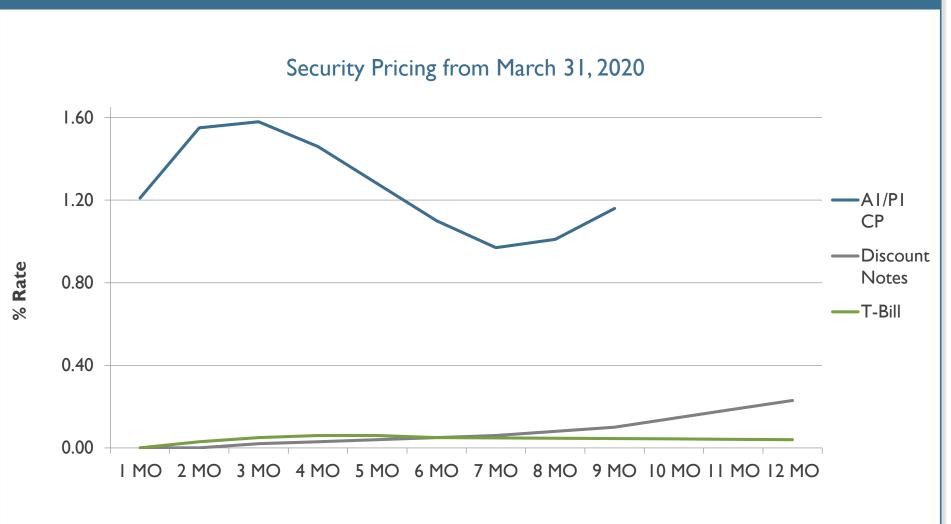


Comparative Historical Yield Curves



• The 10-year U.S.Treasury Note reached a record low yield of 0.543% on March 9, 2020.

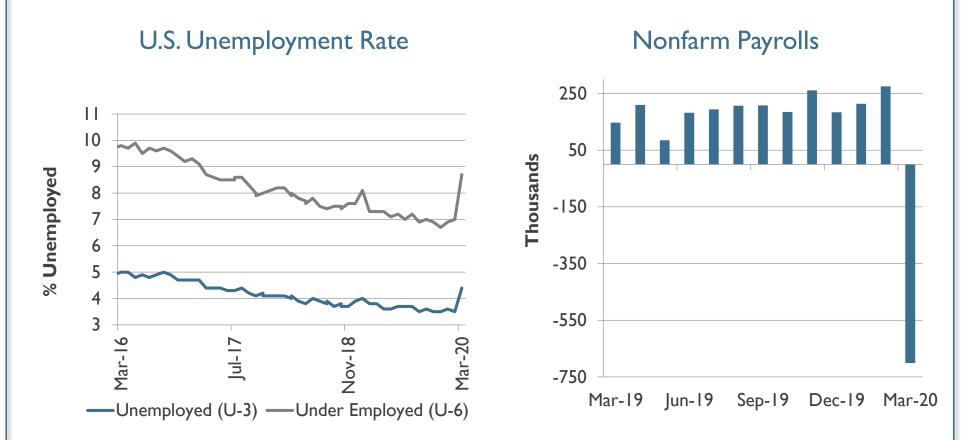
Money Market Yield Curves

- Adding credit in the form of commercial paper can enhance the yield of the portfolio.

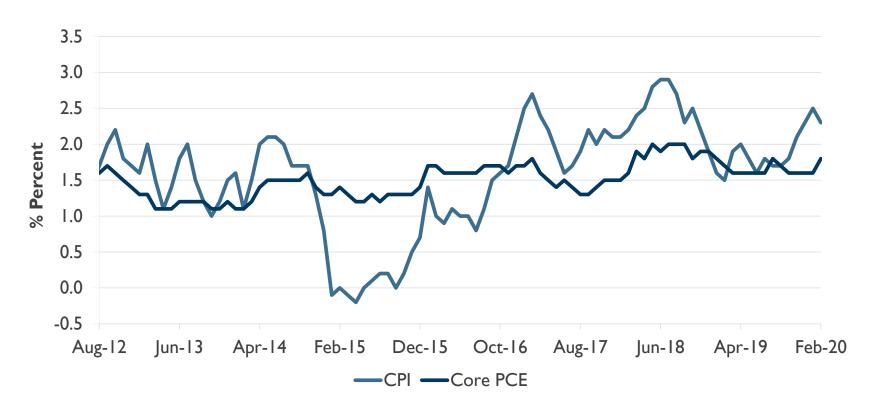

Labor Market



- The March unemployment rate increased to 4.4% and the underemployment rate increased from 7.0% to 8.7%.
- March payrolls decreased by a staggering -701k, well below the expectations of -100k.
- Average hourly earnings increased at an annualized rate of 3.1% on a year-over-year basis in March.

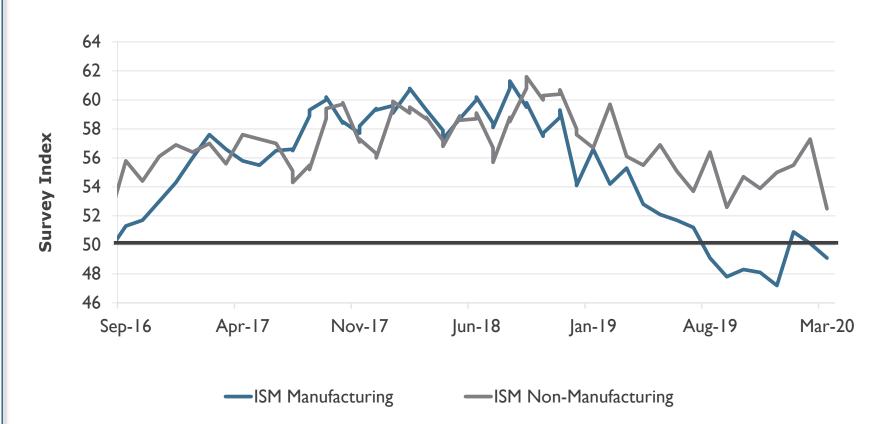
Inflation



- Headline CPI for February was at 2.3% on a year-over-year basis due to rising gasoline prices. Core CPI (less food and energy) increased at a 2.4% year-over-year.
- The Fed's preferred measure of inflation, core PCE, increased 1.8% in February, remaining below the Fed's target of 2.0%. Policymakers view the PCE core index as a better indicator of underlying price trends. Core PCE has been at or above the Fed's 2.0% target only 11% of the time in the current economic cycle.



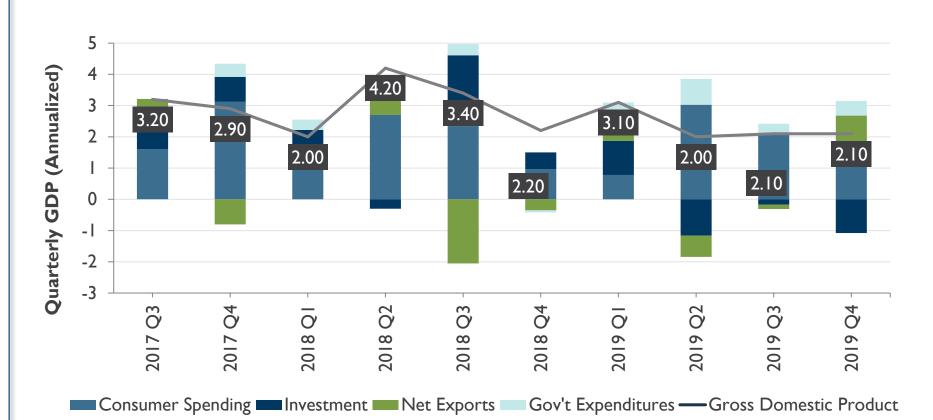
Institute of Supply Management



- ISM Manufacturing for March decreased to 49.1 from 50.1 in February as the report noted that global supply chain impacts are being felt across "most, if not all" manufacturing industries.
- ISM Non-Manufacturing (service) decreased to 52.5 in March. The median forecast called for a decline to 43.0 due to the impending impact of COVID-19 to the U.S. economy.



Contributions to Percent Change in Real GDP



- The U.S. economy expanded at a 2.1% annualized pace during the fourth quarter of 2019, in line with the 2.0% of the previous quarter.
- Full-year GDP grew at 2.3% for 2019, a contraction from the 2.9% level experienced in 2018.
- Consumer spending, the biggest part of the economy, slowed to a 1.7% pace in the fourth quarter. Business and residential investment continued to be a drag on growth statistics.

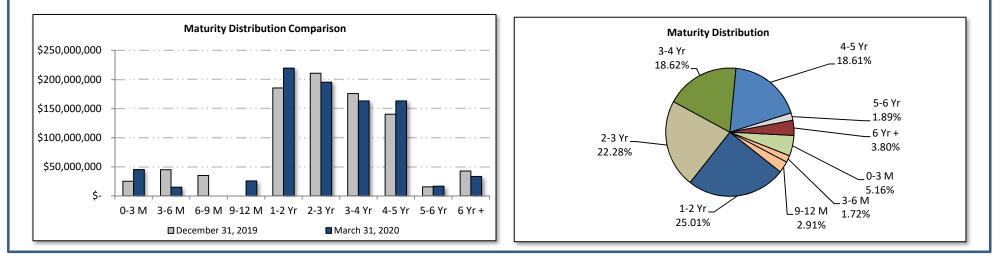

City of Fort Worth Aggregate Maturity Distribution Market Value Basis December 31, 2019 to March 31, 2020

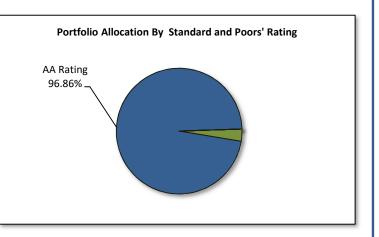

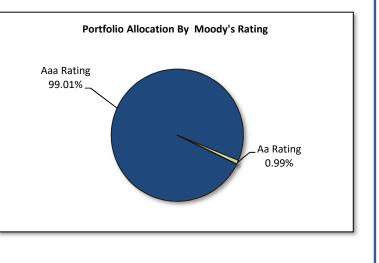




City of Fort Worth Aggregate Rating Distribution Market Value Basis as of March 31, 2020

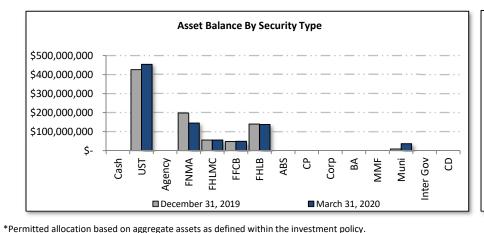

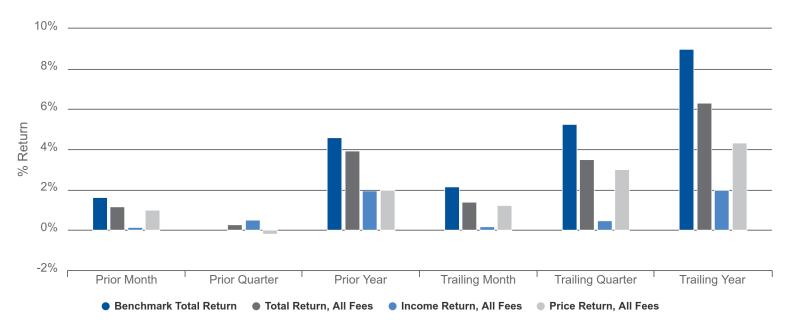
Total Return v. Benchmark

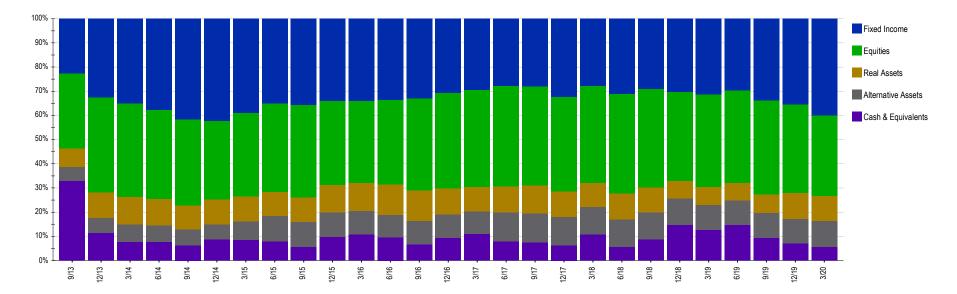

Commodities: Bloomberg Commodity Total Return (Bloomberg Commodity Total Return Index) reflects the returns that are potentially available through an unleveraged investment in the futures contracts on 19 physical commodities comprising the Index plus the rate of interest that could be earned on cash collateral invested in specified Treasury Bills. The Index is a rolling index rebalancing annually.

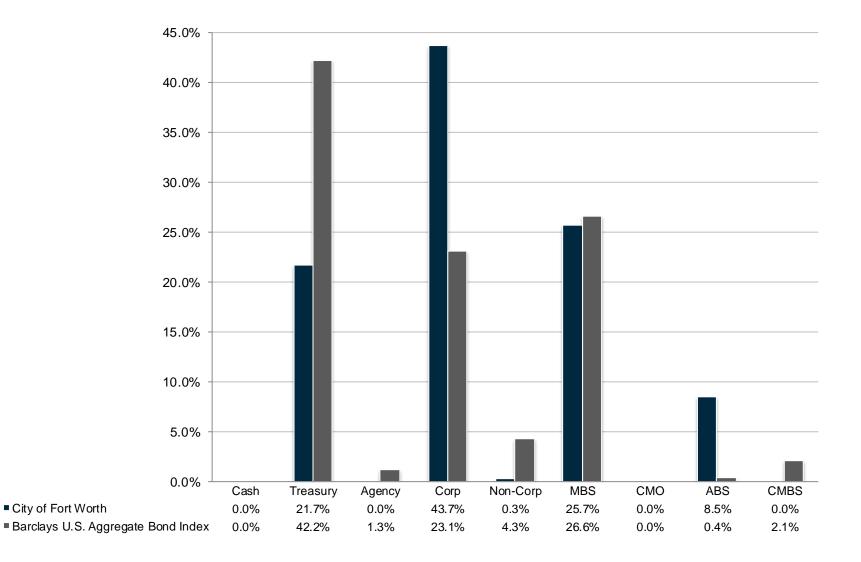

Fixed Income Portfolio: Sectors As of First Quarter 2020

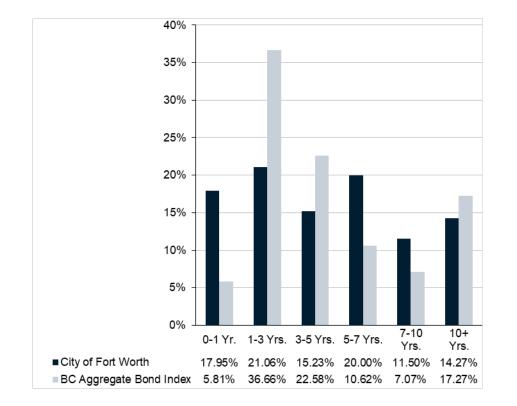


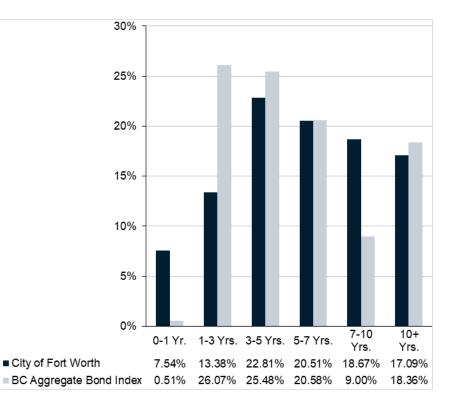

General Market Commentary

- Financial markets experienced unprecedented turmoil during March, as COVID-19 spread rapidly
 across the globe. Containment efforts to reduce the number of infections have resulted in a standstill of
 many world economies.
- The unprecedented lockdown and "shelter in place" orders have materially impacted supply and demand dynamics at many stages of the supply chain. Supply chain disruptions have shifted from initial pressures following China's lockdown, to unprecedented logistics issues across the globe. While the true economic impact of COVID-19 is still unknown, many economists and organizations are predicting negative global growth throughout 2020, with some economists predicting between a 10% -30% drop in US GDP in the second quarter.
- In the United States, the Federal Reserve slashed interest rates 150 basis points during March to a range of 0% - 0.25% and announced the restart of quantitative easing to support business growth and market liquidity. Additionally, the US Congress and President Trump passed the CARES stimulus package, which provides financial assistance to US consumers and small businesses, as well as large corporations.
- Equity markets posted negative returns in March as the S&P 500 (Cap Wtd) Index returned -12.35% and the MSCI EAFE (Net) Index returned -13.35%. Emerging markets returned -15.40% as measured by the MSCI EM (Net) Index.
- The Bloomberg US Aggregate Bond Index returned -0.59% in March, underperforming the 2.08% return by the Bloomberg US Treasury Intermediate Term Index. International fixed income markets returned -2.88%, as measured by the FTSE Non-US World Gov't Bond Index.
- Public real estate, as measured by the FTSE NAREIT Eq REITs Index (TR), returned -21.92% in March and -0.35% over the trailing five-year period.
- The Cambridge US Private Equity Index returned 7.76% for the trailing one-year period and 11.68% for the trailing five-year period ending September 2019.
- Absolute return strategies, as measured by the HFRI FOF Comp Index, returned -6.16% for the month and -3.94% over the trailing one-year period.
- Crude oil's price fell by 54.24% during the month, and has decreased by 65.95% YoY.

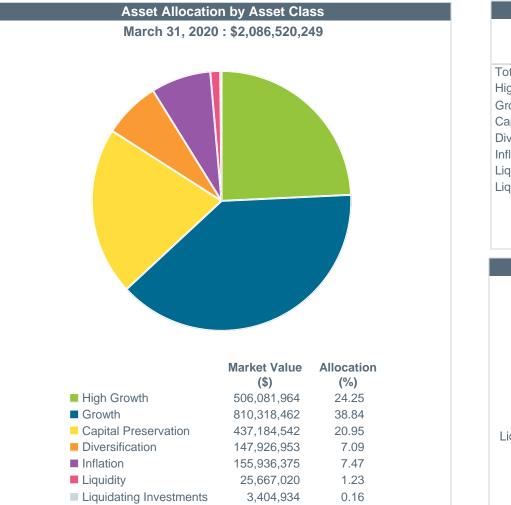

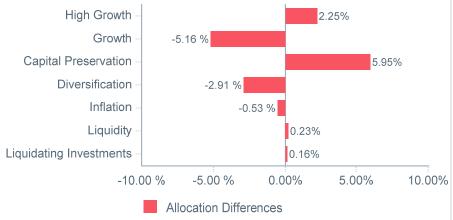

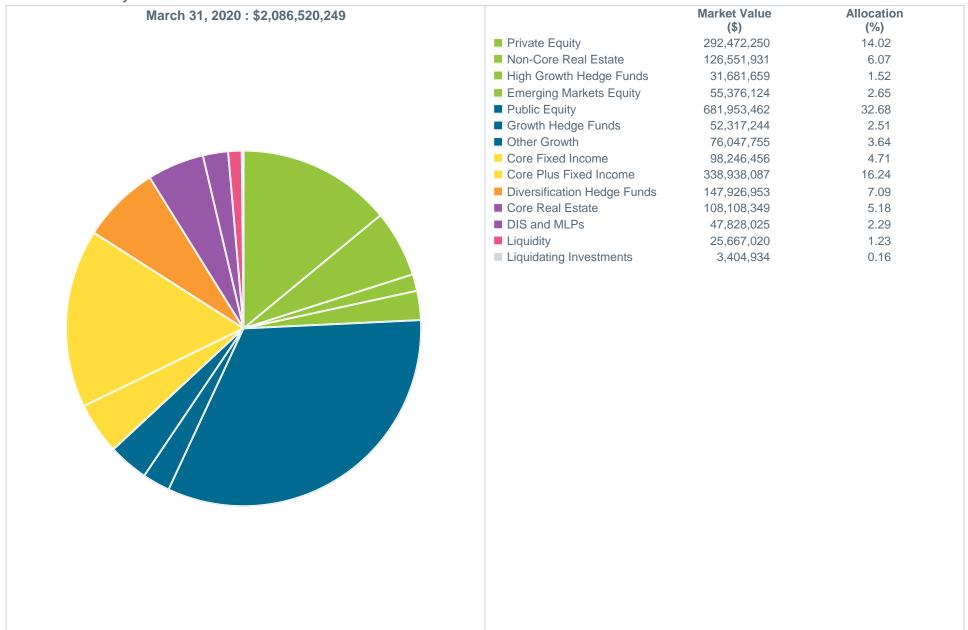
Asset Allocation vs. Target Allocation Differences
