The Public Funds Investment Act (Chapter 2256, Texas Government Code Sec. 2256.023) requires the entity's Investment Officers to prepare and submit to the governing body, a written report of investment transactions for all funds subject to the requirements of the Public Funds Investment Act (the City's General Investment Portfolio).

The attached Investment Report covers the quarter ending June 30, 2021 ("Period-to-Date or PTD"). The report describes the economic trends affecting the City's investments along with a summary of the City's investment performance during the reporting period.

Accompanying the General Investment portfolio report are the quarterly investment reports of the Fort Worth Permanent Fund Trust, the Other Post-Employment Benefits ("OPEB") Trust, and the Fort Worth Employees Retirement Fund. Each section has been bookmarked within the PDF for ease of reference.



## Federal Reserve Economic Forecast


### U.S. Real Gross Domestic **Product** (Annual)

# Money Market Yield Curves






- The yield spread between short-term Treasuries and agency discount notes remains at very tight levels.


# Labor Market



- The June unemployment rate increased from 5.8% to 5.9%; the underemployment rate decreased from 10.2% to 9.8%.
- March payrolls increased by 850k, up from the 559k jobs added in May and above the expected June payrolls figure
  of 720k.
- Average hourly earnings increased at an annualized rate of 3.6% on a year-over-year basis in June.




# Inflation



- Headline CPI for June rose 5.4% on a year-over-year basis. Core CPI (less food and energy) increased 4.5% from the prior year in June.
- The Fed's preferred measure of inflation, core PCE, increased 3.4% in May, remaining above the Fed's target of 2.0%. Policymakers view the PCE core index as a better indicator of underlying price trends.
- Inflation is likely to accelerate as massive fiscal stimulus and accommodative monetary policy fuel substantial economic growth. Will inflationary pressure from rising wages and manufacturing bottlenecks prove to be transitory or more persistent?


# Institute of Supply Management



- ISM Manufacturing for June decreased from 61.2 in May to 60.6. U.S. manufacturing continued to expand at a solid yet slightly slower pace in June while a measure of prices paid for materials jumped to an almost 42-year high. Material shortages, shipping delays, and a lack of skilled workers remain concerns.
- ISM Services decreased to 60.1 in June versus 63.5 expected and 64.0 in May. While cooling from a month earlier, the report still shows solid demand for services like restaurant dining, hotel stays, and travel. Economists warn that a limited supply of workers and materials may somewhat temper the pace going forward.



# Contributions to Percent Change in Real GDP



- The U.S. economy grew at a 6.4% annualized pace during the first quarter of 2021. The increase in first quarter GDP reflected the continued economic recovery, reopening of establishments, and continued government response related to the COVID-19 pandemic.
- Personal consumption, the biggest part of the economy, rose 11.4% in the first quarter after it rose 2.3% in the fourth quarter.














# Fixed Income Portfolio: Sectors As of Second Quarter 2021




Capital Markets Review As of June 30, 2021

#### **General Market Commentary**

- Equity markets finished June with mixed results. US equity markets generally outperformed international
  equity markets, and growth stocks vastly outperformed value stocks both in the US and abroad. The S&P
  500 and technology-heavy Nasdaq Composite finished June at record highs after another consecutive
  monthly gain.
- Markets reacted positively to the Federal Reserve's announcement that it would begin to slowly wind down
  its \$13.7 billion corporate bond position it initiated during the height of the COVID-19 pandemic to stabilize
  investment grade bond markets. However, some uncertainty following the Fed's June meeting limited the
  upside in the month. While no change in monetary policy was announced, Fed officials now expect to raise
  rates by the end of 2023.
- Inflation continues to weigh on investors' minds as the Consumer Price Index (CPI) increased 5% in May on a year-over-year basis, the largest increase in CPI since August 2008. The 5% increase outpaced economists projections of a 4.7% YoY increase.
- Equity markets posted mixed returns in June as the S&P 500 (Cap Wtd) Index returned 2.33% and the MSCI EAFE (Net) Index returned -1.13%. Emerging markets returned 0.17% as measured by the MSCI EM (Net) Index.
- The Bloomberg US Aggregate Bond Index returned 0.70% in June, outperforming the -0.07% return by the Bloomberg US Treasury Intermediate Term Index. International fixed income markets returned -2.10%, as measured by the FTSE Non-US World Gov't Bond Index.
- Public real estate, as measured by the FTSE NAREIT Eq REITs Index (TR), returned 2.61% in June and 6.31% over the trailing five-year period.
- The Cambridge US Private Equity Index returned 48.11% for the trailing one-year period and 17.51% for the trailing five-year period ending March 2021.
- Absolute return strategies, as measured by the HFRI FOF Comp Index, returned 0.45% for the month and 18.20% over the trailing one-year period.
- · Crude oil's price increased by 10.78% during the month, and has increased by 87.09% YoY.






