SUBJECT:	(ALL) Approve Reallocation of American Rescue Plan Act State and Local Fiscal Recovery Funds in an Amount Up to \$214,931.00, Consisting of Up to \$105,319.00 for the Neighborhood Wi-Fi Project, Up to \$84,876.00 for Public Events Capital Projects, and Up to \$24,736.00 for Information Technology Services Infrastructure; Adopt Appropriation Ordinance; and Amend the Fiscal Years 2026-2030 Capital Improvement Program				

RECOMMENDATION:

It is recommended that the City Council:

1. Approve the reallocation of American Rescue Plan Act, Subtitle M (Coronavirus State and Local Fiscal Recovery Funds) as follows: (i) up to \$105,319.00 to support the Neighborhood Wi-Fi activities (City Project No. 103165); (ii) up to \$84,876.00 to support the Public Events Capital Restore Will Rogers Memorial Center Stall Panel Replace project (City Project No. 104397); and (iii) up to \$24,736.00 in support of the American Rescue Plan Act Information Technology Service Initiatives project for the purpose of Windows 11 upgrades (City Project No. 103746);
2. Adopt the attached appropriation ordinance adjusting estimated receipts and appropriations in the Grants Capital Projects Federal Fund as follows: (i) increase the Public Events Capital Restore project of American Rescue Plan Act Will Rogers Memorial Center Stall Panel Replace project (City Project No. 104397) by \$84,876.00 and decrease the Meadowbrook Golf Club - Maintenance Building project (City Project No. 104389) by the same amount; and (ii) increase the American Rescue Plan Act Information Technology Service Infrastructure project (City Project No. 103746) by \$24,736.00 and decrease the Meadowbrook Golf Club - Maintenance Building project (City Project No. 104389) by the same amount; and
3. Amend the Fiscal Years 2026-2030 Capital Improvement Program.

DISCUSSION:

The purpose of this Mayor and Council Communication (M&C) is to address recommended reallocation of identified American Rescue Plan Act (ARPA) State and Local Fiscal Recovery Funds (SLFRF) residuals totaling \$214,931.00, consisting of \$105,319.00 in Non-Revenue Recovery and \$109,612.00 in Revenue Recovery, to allowable ARPA projects.

The City of Fort Worth received ARPA SLFRF of \$173,745,090.00, consisting of \$87,024,408.00 to be spent on Public Health and Negative Economic Impacts (Non-Revenue Recovery), and \$86,720,682.00 to assist the City in providing governmental services (Revenue Recovery).

Current Treasury guidelines allow identified ARPA residual revenue in both the Non-Revenue and Revenue Recovery categories to be reallocated to approved ARPA projects within the same category to cover shortfalls in funding because of unforeseen but necessary expenditures for project completion. These reallocations will allow the City to utilize the funds locally and avoid returning surplus to the Treasury. All ARPA funds must be expended by December 31, 2026.

During the most recent ARPA reporting cycle, the Financial Management Services Department (FMS), in cooperation with departmental project managers, identified residual revenue from current ARPA projects that are completed or nearing completion. FMS then contacted City departments with ongoing ARPA projects to determine needs for additional revenue to cover expenditures meeting the stated criteria and presented findings and recommendations to the City Manager's Office.

Residual revenue in the Non-Revenue Recovery category totaling \$105,319.00 has been identified within the following projects:

ARPA Reallocation Recommendations:

It is recommended that the \$105,319.00 in residual revenue in the Non-Revenue category be reallocated to the Neighborhood Wi-Fi Project for:

Circuit Funding for September-October 2026, and
NEMA box removal

ARPA SLFRF Non-Revenue funds support the Information Technology Services (ITS) Neighborhood Wi-Fi project, delivering internet connectivity to Rosemont, Ash Crescent, Northside, and Stop Six neighborhoods, which were previously not served with affordable internet. Because these funds are appropriated in a life-to-date grant operating fund, there is no need to adopt an appropriation ordinance to effect this reallocation if approved.

It is recommended that the \$109,612.00 in residual revenue in the Revenue category be reallocated as follows:

Public Events Capital Restore Will Rogers Memorial Center (WRMC) – Barn doors \$84,876.00

ITS Infrastructure – Windows 11 Update \$24,736.00

Additional ARPA SLFRF Revenue Recovery funding will allow for the installation of a greater number of matching doors throughout the WRMC after cost estimates came in higher than anticipated. The allocation also provides support for the ongoing ITS Initiatives project to deliver Windows 11 upgrades for City staff. Because these funds were appropriated to a specific capital project, adoption of the attached appropriation ordinance is needed to move the funds to these projects.

Additional funding for these projects was not included in the Fiscal Years (FY) 2026-2030 Capital Improvement Program. The action in this M&C will amend the FY2026-2030 Capital Improvement Program as approved in connection with Ordinance 27979-09-2025 Section 8 CAPITAL IMPROVEMENTS.

Allocation of ARPA Subtitle M Funding:

ARPA Section 9901, Subsection 603(c)(1)(A) provides funding to support initiatives for communities disproportionately impacted by the COVID pandemic. ARPA Section 9901, Subsection 603(c)(1)(C) provides funding to offset government entities' lost revenue as a consequence of the pandemic. Per U.S. Treasury guidelines, all general ARPA funds must be fully obligated by December 31, 2024 and fully expended by December 31, 2026.
