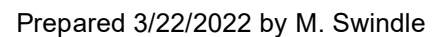

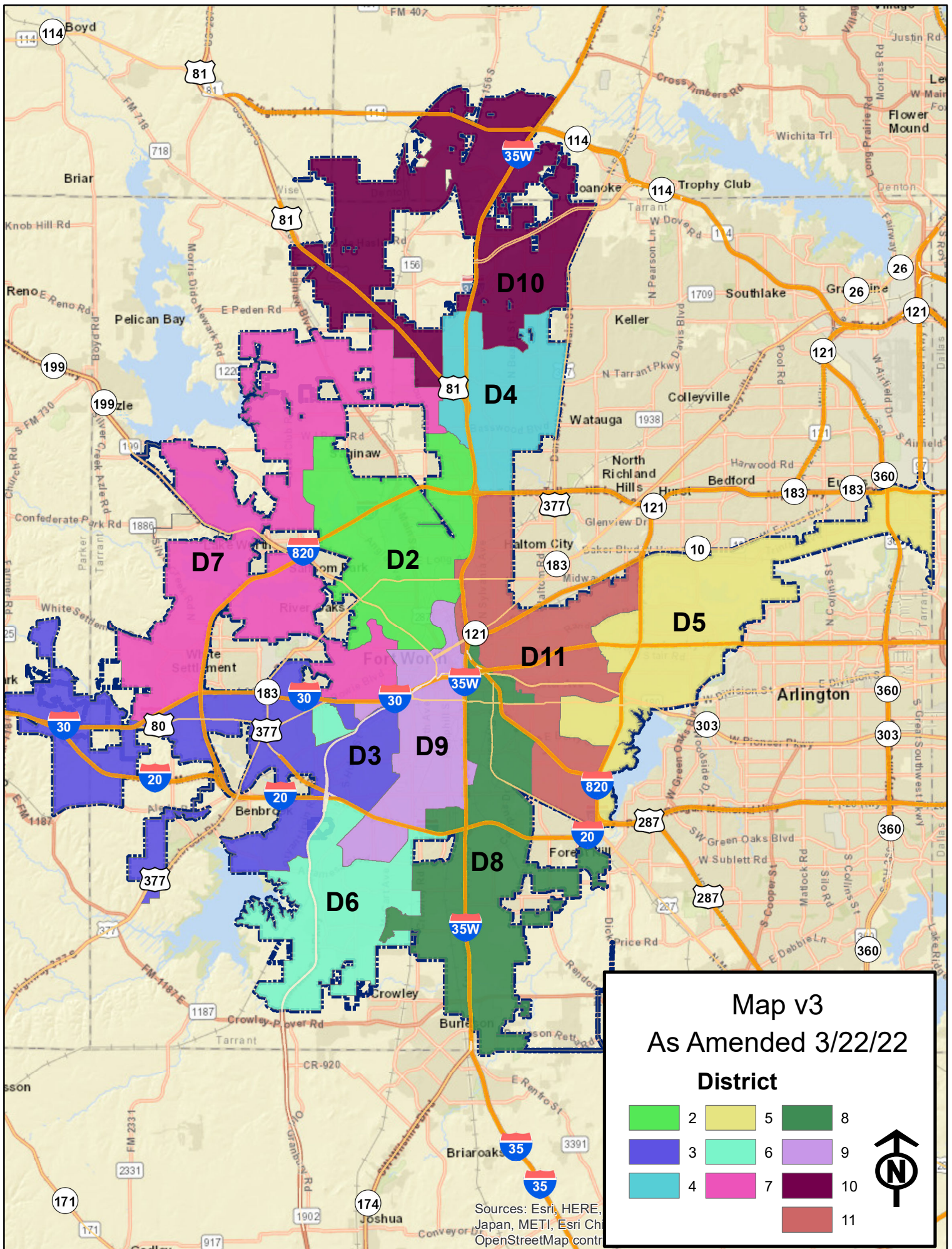

Submitter Comments: X Revised v4amended is solidly based upon Map X which was recommended to the Council by the Redistricting Task Force with the recommendation that Como COI be placed in D6. Additional feedback recommended that the Greater Historic Stop Six COI be placed in D5 along with Stop Six-Poly and Sunrise Addition. Pablo Calderon amended v4 map to incorporate these changes.

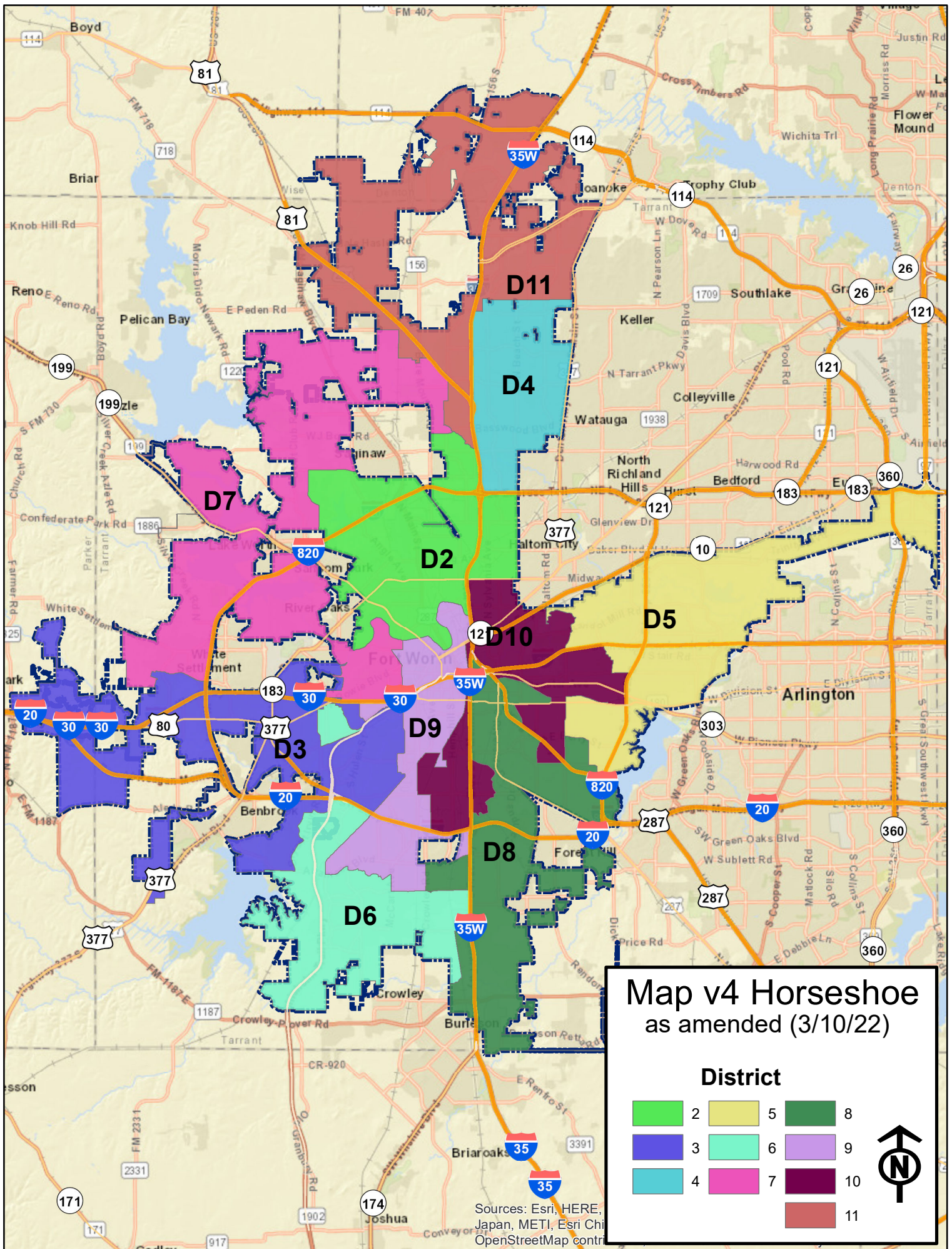
X Revised v4amended draws a connector for D3 to reach Camp Bowie Business District using the lake and watershed area from Locke Avenue to Vickery. However, this connector is incomplete; ask that Michelle make necessary changes to connect. Note: Pablo indicated that residences in the watershed are part of Como, not D3. Not included in the Camp Bowie Business District are areas that may have one or two businesses with the remainder being residences. Lovell and Donnelly are included in the Camp Bowie Business District whose southern parts contain residences.

Overton, Tanglewood, Colonial Hills, and Foster Park put in D3.

Westcliff remains in D9. Note: Rosemont and South Hills are split intentionally.

Handley is in D5 and D8.

Pablo split Oakridge Terrace. A small area southeast of the intersection of Seminary South and Campus intersection is in D8 and has about 2,500 and is 8% Hispanic. The area in the northwest is in D11 and has about 2,000 and is 50% Hispanic. There is a large area of vacant land between the two. Our preference would be that this not be considered
