Overall Progress Narrative:

During the past quarter, the City of Fort Worth continued developing the policies and procedures for the single family homeowner-occupied rehabilitation program, named Homeowners Assistance Repair and Rehabilitation Program (HARRP). In addition, staff created the Language Access Plan, Anti-Fraud, Waste, and Abuse policy, and began developing the intake application in Neighborly Software and the Uniform Relocation Act (URA) policy, and the Residential Anti-displacement and Relocation Assistance Plan (RARAP). In the following quarter, we plan to submit the Action Plan substantial amendment for approval by Fort Worth City Council along with a Public Hearing, expected to be completed in December 2024. This will include proposed changes to the program design for single family housing, removal of Infrastructure, and adding line item budget for Planning. Staff plans to finalize the HARRP, RARAP, and URA policies and develop and finalize the Mitigation policy.
