Overall Progress Narrative:

During the past quarter, the City of Fort Worth finalized the Residential Relocation Assistance Plan (RARAP), and the Relocation Plan, which includes optional relocation assistance. The City also onboarded our consultant, ICF, to assist with staff augmentation for the CDBG-DR grant. As a part of the implementation process, staff met with the City Manager's Office in December to provide an overview of the CDBG-DR funded programs, proposed activities, and year-to-date accomplishments. Based on recommendations from City leadership, a new mitigation activity was proposed that included purchasing salt and brine equipment to provide improved winter street treatments. This resulted in extensive changes to the Mitigation Plan guidelines.

In the following quarter, we will submit the Action Plan substantial amendment for approval by Fort Worth City Council along with a Public Hearing, to be completed in January 2025. This will include proposed changes to the program design for single family housing, removal of Infrastructure, adding line item budget for Planning, and increasing budget allocation for Mitigation. Staff plans to finalize the HARRP, RARAP, Mitigation, and URA policies.

To date, primary expenditures have included Administration and Planning for staff managing the program.
