Overall Progress Narrative:

During the past quarter, the Homeowners Assistance Repair and Rehabilitation Program (HARRP) applicant portal, received thirty-one completed applications currently under eligibility review. HARRP entered into a cooperative agreement with the Small Business Administration (SBA) to retrieve HARRP application-related information for duplication of benefit reviews. Contractor agreements for the Cityâ¿¿s Home Repair Program were amended to add CDBG-DR rehabilitation work to existing contracts, along with accepting updated bid pricing from each contractor to include Green Building Retrofit requirements in a separate agreement. Meetings were held with each contractor, and all amendments and agreements have been executed. The Cityâ¿¿s consultant, ICF, completed a comprehensive 3-day in-person training for all staff involved in CDBG-DR program implementation.

In the next quarter, we will develop a robust marketing plan to launch the second phase of HARRP. For current HARRP homeowners in the pipeline, they will be notified of program eligibility and will be led into Inspections.. URA/ORA policy drafts are underway for completion. The Multifamily New Construction and Rehabilitation Program will be finalized, and we plan to advertise the Notice of Funding Availability (NOFA) to attract developers with projects in the pipeline.
