- 2. DO NOT MAIL THIS FORM TO THE ERAP PROGRAM Applicants applying for assistance under the ERAP should upload this form in lieu of a written lease or the Landlord/Tenant Relationship form when completing their on-line application.
- 3. INCLUDE ALL REQUIRED ATTACHMENTS The self-certification requires certain documents be included with the certificate. These items should also be uploaded with the form when tenant completes their on-line application. See certificate for list of required documents.
- 4. COMPLETE ALL FIELDS AND QUESTIONS ON THE CERTIFICATE
- 5. SIGN THE CERTIFICATE The certificate must be signed by the tenant head of household.
