# **Reason for Changes**

• Spectrum of cost recovery in public services

2

- Enterprise funds recover 100% of costs
- Most services are at least partially subsidized
- Fee changes grounded in cost basis and equity
  - CPI increases
  - Market benchmarks
  - New fees for direct cost offsets



- Informally conveys fee changes prior to fee ordinance and budget adoption
- Traditionally includes fee name, new amount, change amount; change explanation included for FY2024
- Ideally fee changes are constant throughout budget development

Fee Change BR and Recommended Book – Budget Ordinance	Aviation (fees not yet finalized) and Municipal Golf (optional new top range withdrawn)

## FY2024 Fee Changes

- 180 fee changes
  - **34** new fees
  - 135 fee increases
  - 9 fee decreases
  - 2 changes to base of assessment (daily to monthly, effective decrease)
- 8 departments have fee changes (Aviation, Code, Library, PARD, PD, Public Events, TPW, Water)

• 7 funds have fee changes (GF, C&T, Golf, Municipal Airports, Solid Waste, Stormwater, Water)
