


Project Scope

Objectives include:

- Improve pedestrian mobility, connectivity, and safety by constructing sidewalks and ADA-compliant pedestrian curb ramps along Glasgow Road between DeCory Rd. and Highland Hills Community Center and along Oak Grove Road from Roma Ln. to Engblad Dr. Existing Sidewalks will be left undisturbed with a few replacement areas.
- Project improvements will provide safe access to surrounding churches, businesses, public transit stops, a park, and a community center.
- Project funded by 2022 Bond Program funds




Project Plan Glasgow Road








Project Plan Glasgow Road






Project Plan Oak Grove Road





- Notifications
- Traffic Control Implementation
- Erosion Control Plan Implementation
- Site Clearing
- Sidewalk and Ramp Prep and Install
- Striping and RRFB Install
- Traffic Control & Erosion Control Removal
- Final Clean Up



Traffic Control

- This project will involve multiple driveway reconstructions. We will replace one panel at a time and provide continuous access to the property at all times.
- We do not anticipate any street closures or detoured streets associated with this project.
