Project Limits



Project Scope

- Traffic Signals will be installed in place of the 4-Way Stop Sign condition to improve traffic movements and provide a higher level of safety for pedestrian traffic.
- Pedestrian signal poles will be installed at each corner
- Left turn lanes will be constructed for both northbound and southbound N Beach Street.
- Finally, crosswalk improvements, ADA ramps, and re-stripping will be constructed
- Conduit will be installed for HOA use

Typical Construction Process

- Notifications
- Traffic Control Implementation
- Erosion Control Plan Implementation
- Site Clearing
- Utility Work
- Subgrade Placement and Stabilization
- Pavement and Sidewalk Construction
- Traffic Signal Installation
- Landscaping / Sodding
- Traffic Control Removal
- Final Clean Up

Project Schedule and Notification

- Projected Start: Estimated May 2025
- Project Duration: 210 Calendar Days
- Projected Completion: December 2025
- Working Hours
 - 9 AM – 4 PM M-F (Standard Hours)
 - 9 AM – 5 PM (Weekend Hours if Requested in Writing and Approved)
- Project Notification
 - Variable Message Boards (Placed 7 Days Before Construction)
 - Project Signs (Placed 7 Days Before Construction)
 - Door Hangers on Residences and Businesses (7 Days Before Construction)

Project schedule could be affected by unforeseen events such as utility conflicts or weather

Summary

- Intersection Improvements to include:
 - Traffic Signals
 - Pedestrian Signal Poles
 - Left Turn Lanes for North Bound and South Bound N Beach Street
 - Crosswalks and Ramps
- Traffic will remain open in all directions throughout the project duration
