Consultant Project Manager – Professionals responsible for the design and coordination of the resources needed for the survey, right-of-way acquisition, utility relocations, permit submittals, bidding and construction management and ensuring the elements of the pre-defined scope are included in the final design.

Project Scope

- Roadway Widening from Boat Club Road to Elkins School Road
 - Modified traffic signal at Boat Club Road
 - Warrant Study to determine if a traffic signal is needed at Bowman Roberts Road (includes analysis to determine best design for this intersection)
 - Construction of a 4-lane divided roadway
 - 10 ft Multi-use trail on north side of the roadway
 - 10 ft Multi-use trail on south side of the roadway, except in areas where a 5-7 ft sidewalk will be constructed to reduce impacts to property owners
 - Drainage Improvements including elimination of roadside ditches
 - Channel and Culvert improvements north and east of Elkins School Road
 - LED Streetlights
- Design sections designed to save trees where possible and reduce impacts to existing homes and parking areas










Proposed Typical Sections

Typical Section (90 ft) From Boat Club Rd. to Innisbrook Lane

- 4-Lane Divided Roadway (2-11' lanes)
- 90' of Right-of-Way
- Design Speed 30-mph to 35-mph




90-foot Typical Section




Proposed Typical Sections

Project Schedule and Budget

- Design Completion: March 2024
- Right-of-Way Acquisition Completion: Summer 2024
- Utility Relocations: Fall 2024-Summer 2025
- Construction Start: TBD*
- Construction Duration: 24 Months
- * Construction start date contingent upon completion of Cromwell Marine Creek Road & Bailey Boswell Road

Project Budget: \$30M
