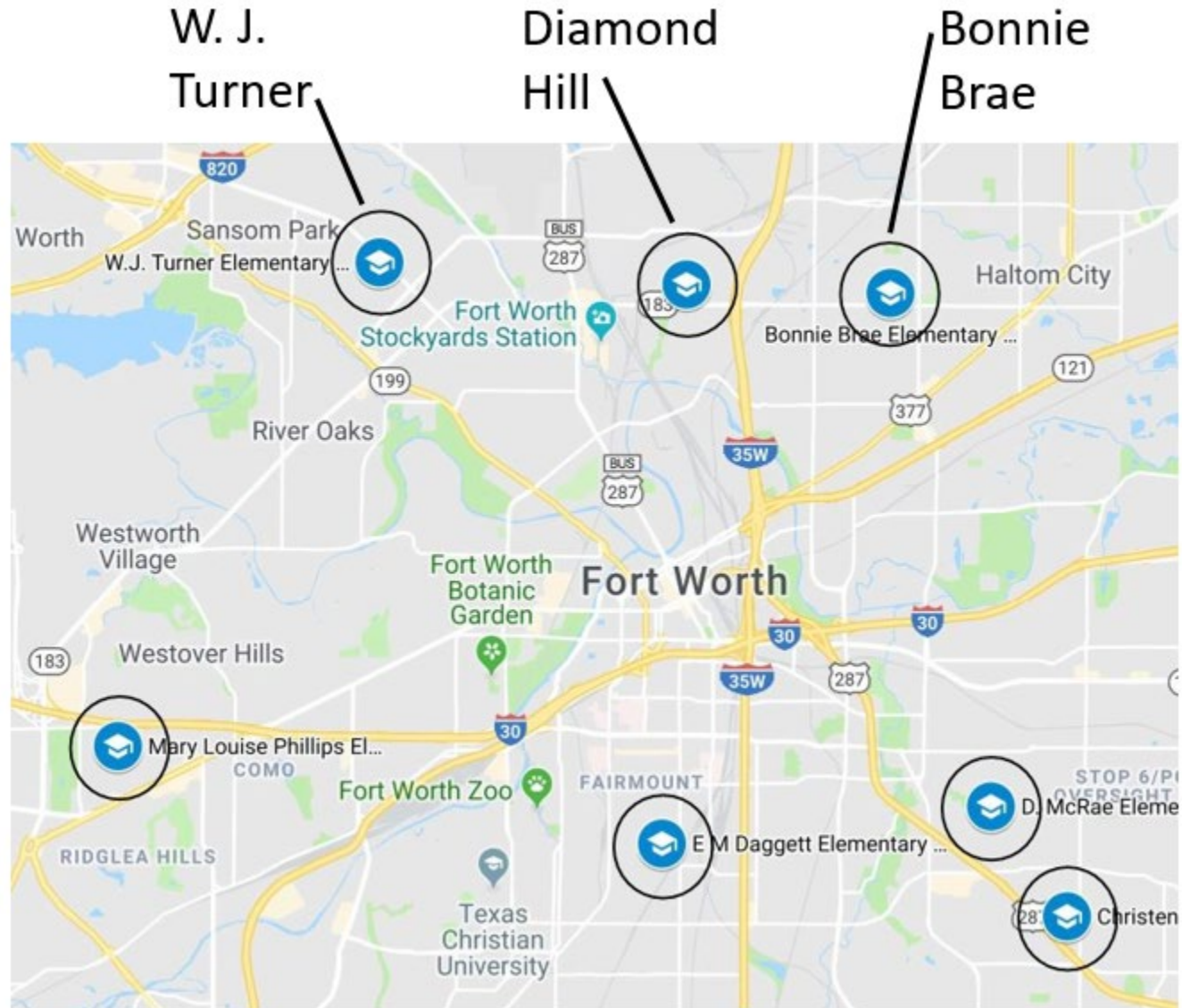

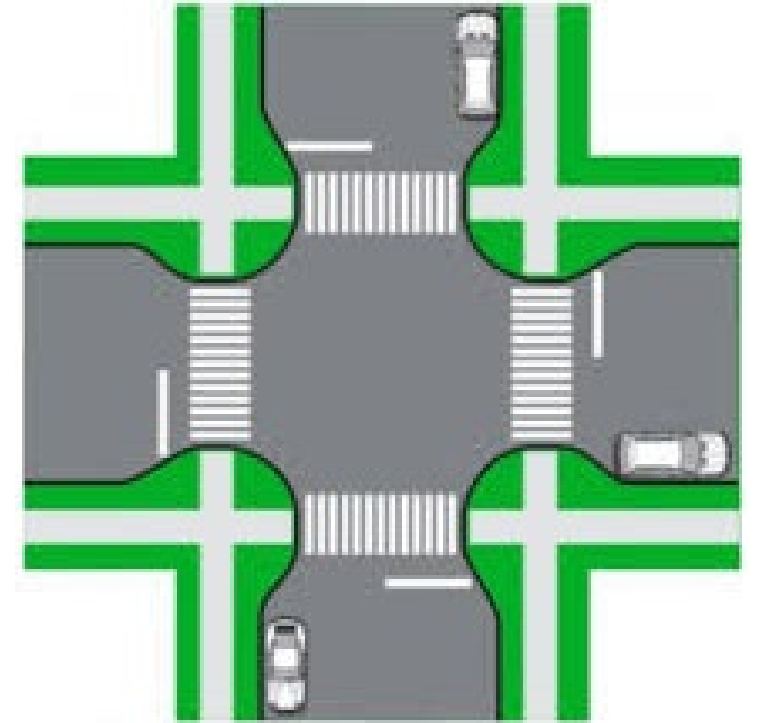

Overall Project Scope

Project area is approximate 0.25 mile radius from each school


- New sidewalks
- Replacement of non-compliant sidewalks
- Driveway reconstruction
- Curb ramps
- Signs and pavement markings including crosswalks
- At Diamond Hill:
 - Curb bulbouts in Schwartz Avenue at Dewey Street and at Loraine Street
- At W. J. Turner:
 - Curb bulbouts in Azle Avenue at Robinson Street and at Macie Avenue

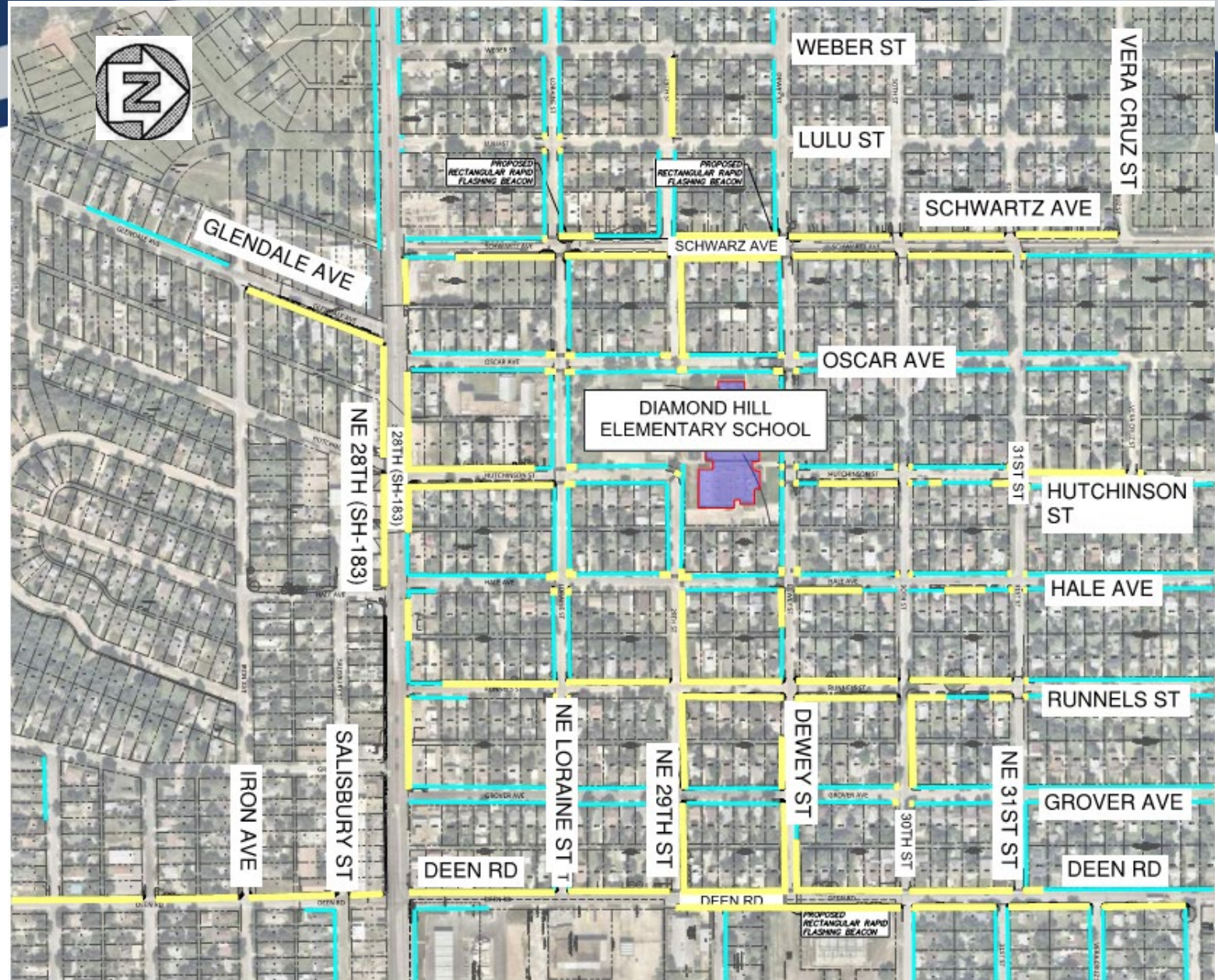

- EXISTING CURB RAMP AND SIDEWALK LOCATIONS

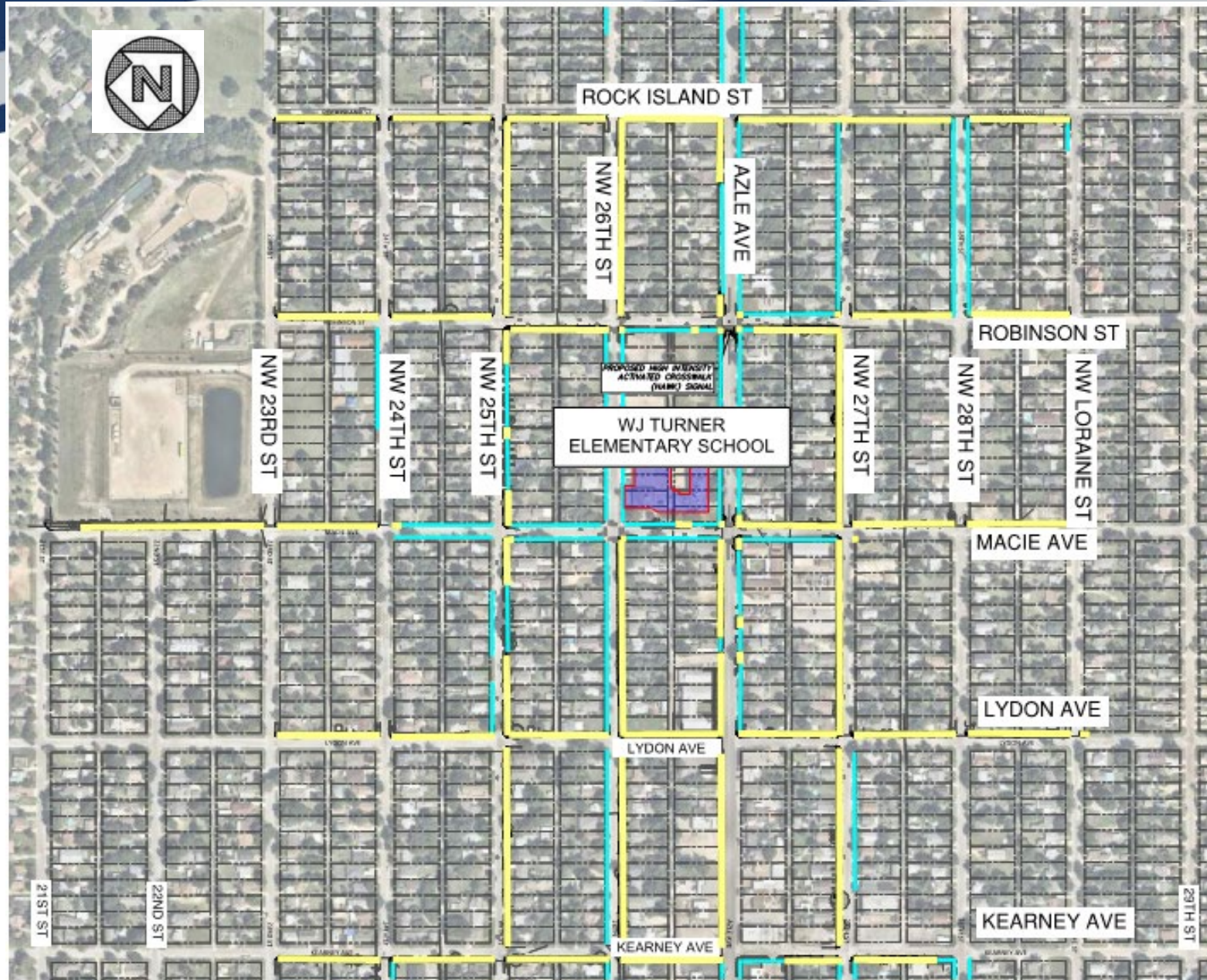

Typical Construction Process

- Notifications
- Traffic Control Implementation
- Erosion Control Plan Implementation
- Site Clearing
- Underground Utility Work / Adjustments
- Driveway Approach Removals and Replacements
- ADA Ramp and Sidewalk Construction
- Landscaping / Sodding of disturbed areas
- Traffic Control Removal
- Final Clean Up

Project Schedule and Notification

- Estimated Start: April 2022
- Project Duration: 300 Calendar Days
- Estimated Completion: February 2023
- Working Hours
 - 7 AM – 6 PM M-F (Standard Hours)
 - 7:30-8:30 AM & 3:30-4:30 PM M-F (Closures prohibited immediately adjacent to School)
 - 9 AM – 5 PM (Weekend Hours if Requested in Writing and Approved)
- Project Notification
 - Project Signs (Placed 7 Days Before Construction)
 - Door Hangers on Residences and Businesses (7 Days Before Construction)

Project schedule could be affected by unforeseen events such as utility conflicts or weather
