


#### Project Background

- Combined project Water, Sanitary Sewer, and Storm Water
- Reasons for project:
  - Frequent flooding and undersized drainage pipes
    Undersized water pipes
  - $\odot$  Aging and undersized sanitary sewer pipes
- Final phase of drainage project




#### Storm Water



- 3 phase drainage improvement project
  - Phases 2A and 2B are complete






### Project Updates

- Construction on W. Seminary Dr. and Cherokee Trail is complete.
- Contractor is working on inlets, the storm drain outfall, and rebuilding the roadway on Trail Lake Dr.
- Trail Lake Dr. closure has been extended to January or February.
  - Delays from franchise utility conflicts, additional water pipe installation, and easement acquisitions.






## Project Updates

- Additional water line installation has been added on Wyndale Ct., Sierra Ct., and Trail Lake Dr. between W. Seminary Dr. and South Dr.
  - Existing pipe is cast iron, City priority to replace.
- This work will also be completed by January or February.
- Temporary roadway will be installed on Manderly Pl.





#### **Traffic Impacts**

- Trail Lake Dr. detour will be in place until roadway is reopened.
- Residents on Wyndale Ct. and Sierra Ct. will have temporary periods where driveways are inaccessible, notice will be provided in advance.
- Work on Trail Lake Dr. between W. Seminary Dr. and South Dr. will be scheduled to avoid impacting school bus traffic.

- Please seek alternate routes.
- If traveling south on Trail Lake Dr. the detour will be:
  - Suffolk Dr. to Carolyn Rd. to South Dr.
- Please drive safely on neighborhood streets.
- Trail Lake Dr. between W.
  Seminary Dr. and South Dr. will be open outside of working hours.
