CHAPTER SIX – BENCHMARKING AND IMPLEMENTATION

The proposed programs and policies contained within this plan are a roadmap to implementation of a more walkable Fort Worth. Implementing the plan will require participation by several city departments, partner agencies, and the public taking many years to implement all of the plan's policies, programs, and strategies. It is recommended that this plan be reviewed and updated every five years.

The Walk Fort Worth plan will require the dedicated efforts of City staff to fund, manage, and implement the policies and proposed projects. This plan recommends the creation of a full-time, pedestrian coordinator. This person would provide expertise on pedestrian-related projects and policies to ensure the effective implementation of the Walk Fort Worth Plan. Additional engineering, administrative, and traffic maintenance staff time will be required to support the completion of the plan.

Primary responsibility for implementation of policy directives in this plan should generally come from the Planning and Development Department with input from stakeholder departments and the public. Construction and engineering of sidewalks, signals, mid-block crossings, and other pedestrian related infrastructure should originate from the Transportation and Public Works Department with input from stakeholder departments and the public.

BENCHMARKING

To promote Fort Worth as a safe and walkable city, the Walk Fort Worth Plan specifies the following measurable goals. To achieve these objectives, the Walk Fort Worth Plan recommends implementing the policies and programs in Chapter 3 to create a more walkable city.

GOAL ONE: CREATE A SAFE AND ACCESSIBLE PEDESTRIAN NETWORK

The City of Fort Worth's population is expected to increase one million people by 2030. In order to address the transportation needs of our residents, the City will need to consider a multimodal transportation system including walking. The City of Fort Worth will identify projects, policies, and

programs that will increase the use, safety, and convenience of walking as an integral component of the City's transportation system. The City of Fort Worth aims to increase pedestrian walking trips from 1.2 percent in 2012 to 3.2 percent by 2025 using the five-year estimates from the American Community Survey. (US Census)

Pedestrian crashes are preventable. Nationwide, pedestrians are over-represented in the crash data, accounting for more than 13 percent of fatalities but only 10.9 percent of trips. As with every mode of travel, there is clearly some risk associated with walking. However, walking remains a healthful, inherently safe activity for tens of millions of people every year. It is recommended the City of Fort Worth identify projects, policies, and programs that will increase the safety of pedestrians by decreasing the pedestrian fatality rate by 15 percent by 2025 using TxDOT Crash Records Information System data. (TxDOT, 2012)

Key policies and programs for implementation include the following:

- ★ Increase the minimum sidewalk width
- ★ Design streets for slower speeds
- ★ Update the citywide Complete Streets Policy
- ★ Update the policy on Street Connectivity
- † Investigate the cause of pedestrian-related crashes at high crash locations and develop solutions
- Continue the use of road diets as a way to reduce speeds and increase buffer between sidewalks and travel lanes
- Educate all road users on traffic laws.

GOAL TWO: IMPROVE THE WALKING EXPERIENCE FOR A HEALTHIER COMMUNITY

Nearly half of Tarrant County residents met the recommendations for physical activity (at least 30 minutes per day at least five days per week). Additionally, 19 percent of children aged 2-14 are obese. In order to promote a healthier community, this plan recommends investing time and resources into providing opportunities and encouragement for residents who wish to be more physically active. This plan recommends working towards an increase of adults meeting the recommendations for physical

activity from 47.4 percent to 60 percent and decrease obesity from 19 percent in 2009 to 9% in children ages 2-14 by 2025 using Tarrant County Public Health Behavioral Risk Factor Surveillance System data. (Tarrant County Public Health Department)

Key policies and programs for implementation include the following:

- † Investigate innovative and practical ways to create vibrant public spaces for pedestrians
- ★ Support and expand neighborhood car-free events
- * Work with neighborhoods to install pedestrian wayfinding signage.
- † Develop neighborhood walking maps
