1. **BAC-22-029** Address: 3100 W. Loop 820 S.
Owner: West FW Automotive Real Estate LLC by VLK Architects
Zoning: “F” General Commercial District

a. **Variance:** Permit an auto repair or service facility to have bay doors facing a one-family district when none are allowed.

2. **BAC-23-001** Address: 601 Harrold Street
Owner: Land LB, LLC by Kimley-Horn
Zoning: “MU-2” High Intensity Mixed-Use District

a. **Variance:** Permit a multifamily building with larger setback than allowed.
Maximum setback to a primary street or side street: 20 feet
i. Requested setback: 27 feet along Harrold Street
ii. Requested setback: 46 feet along W. 5th Street (access easement)

3. **BAC-23-002** Address: 6308 South Freeway
Owner: Segadosa LLC by Vertical Bridge
Zoning: “E” Neighborhood Commercial District

a. **Special Exception:** Permit a telecommunication tower.

b. **Variance:** Permit a telecommunication tower to be less than the required distance from a one-family district.

Minimum distance required: 500 feet

Requested distance: 350 feet

- c. Variance: Permit a telecommunication tower to be taller than allowed.

Maximum height allowed: 45 feet

Requested height: 125 feet


