- a. Special Exception: Permit a telecommunication tower up to 45 feet in height.
- **b.** Variance: Permit a telecommunication tower to be less than the required distance from a one-family district.

<u>Minimum distance required</u>: 500 feet <u>Requested distance</u>: 350 feet

c. Variance: Permit a telecommunication tower to be taller than allowed by special exception

Maximum height allowed: 45 feet Requested height: 125 feet
