1. **BAC-23-0004** Address: 7709 & 7711 Camp Bowie Boulevard West
Owner: CCA & CWB LLC by Kelly McReynolds
Zoning: "CB-IA" Camp Bowie Industrial Arts District in the NASJRB Overlay

- a. **Special Exception:** Permit a mobile vendor food court less than 250 feet from a one-family district with no more than 8 food trucks, from 7am to 8pm on Mondays through Fridays only, until February 15, 2028.

D. New Commercial Case

2. **BAC-23-005** Address: 4475 Keller Haslet Road
Owner: Brazos Electric Power Coop by Kimley Horn & Associates
Zoning: "CF" Community Facilities District

- a. **Special Exception:** Permit a telecommunication tower up to 35 feet in height.
b. **Variance:** Permit a telecommunication tower to be less than the required distance from a one-family district.

Minimum distance required: 500 feet
Requested distance: 70 feet

- c. **Variance:** Permit a telecommunication tower to be taller than allowed by special exception

Maximum height allowed: 35 feet
Requested height: 70 feet


