1. <u>FS-24-231 Grove Home Addition Waiver Request – Connectivity to Adjacent Stub-out Street (Section 31-102 (b)(2)): 1 Lot, Council District 11.</u>

Being a 5.021 acre tract of land situated in the P.H. Ahler Survey, Abstract No. 33, in the City of Fort Worth, Tarrant County, Texas, and being part of a called 5 acre tract of land described in certificate of trust, as recorded in Instrument No. D213219890 of the Official Public Records of Tarrant County Texas, and being further described in a deed to W.
