Request a Certificate of Appropriateness for a comprehensive building signage plan that includes two awning signs, one window sign, one wall sign, and two shingle signs with the following waivers from the Downtown Urban Design District Standards and Guidelines:

- a) A waiver from the awning and canopy sign standards to allow two signs per canopy instead of the maximum of one sign per canopy.
- b) A waiver from the awning and canopy sign standards to allow two canopy signs that extend beyond the width of the canopy.
- c) A waiver from the allocation of sign area standards to allow for a 47.85 square foot wall sign, which exceeds the maximum allowable area of 35.00 square feet.
- d) A waiver from the shingle sign standards to allow a shingle sign that is not located within eight feet of an active pedestrian entrance.
