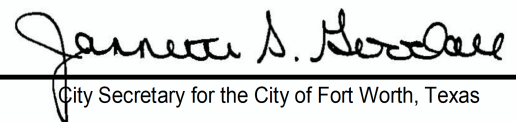
ADJOURNMENT
