- Section 551.076 and Section 551.089, DELIBERATIONS REGARDING SECURITY Deliberate certain security matters in accordance with Sections 551.076 and 551.089 of the Texas Government Code.
- 4. Section 551.074, PERSONNEL MATTERS Deliberate the employment, evaluation, and duties of the City Auditor as authorized by Section 551.074 of the Texas Government Code.
- C. The City Council may reconvene in open session in the City Council Conference Room and act on any item listed on the Executive Session Agenda in accordance with Chapter 551 of the Texas Government Code.
