CITY ATTORNEY

- g. **Legal issues concerning federal Community Project Funding** and,
- h. Legal issues concerning any item listed on today's posted Council Work Session agenda.

CITY MANAGER

1. Section 551.072, DELIBERATIONS REGARDING REAL PROPERTY

Deliberate the purchase, sale, lease or value of real property where deliberation in an open meeting would have a detrimental effect on the position of the City in negotiations with a third party.

2. Section 551.087, DELIBERATIONS REGARDING ECONOMIC DEVELOPMENT NEGOTIATIONS

Deliberate the commercial or financial information or the offer of a financial or other incentive to a business prospect.

3. Section 551.076 and Section 551.089, DELIBERATIONS REGARDING SECURITY

Deliberate certain security matters in accordance with Sections 551.076 and 551.089 of the Texas Government Code.

4. Section 551.074, PERSONNEL MATTERS


Deliberate the employment, evaluation, and duties of the Neighborhood Services Director as authorized by Section 551.074 of the Texas Government Code.
