CITY MANAGER

Deliberate the purchase, sale, lease or value of real property where deliberation in an open meeting would have a detrimental effect on the position of the City in negotiations with a third party.
 - 2. Section 551.087, DELIBERATIONS REGARDING ECONOMIC DEVELOPMENT NEGOTIATIONS
Deliberate the commercial or financial information or the offer of a financial or other incentive to a business prospect.
 - 3. Section 551.076 and Section 551.089, DELIBERATIONS REGARDING SECURITY
Deliberate certain security matters in accordance with Sections 551.076 and 551.089 of the Texas Government Code.
- D. The City Council may reconvene in open session in the City Council Work Session Room and act on any item listed on the Executive Session Agenda in accordance with Chapter 551 of the Texas Government Code.


