
Checklist/Requirements for Wrecking Permit Approvals

Site plan or survey of the property (If multiple structures, indicate which structure is being razed)



Exact square footage for the structure being demolished (Separate permit required for each structure)

Contractor registration number (Not required for residential property owner. Proof of ownership is required)

Wrecking Indemnification form (Provided by Customer Service)

## WRECKING INDEMNIFICATION AGREEMENT

STATE OF TEXAS COUNTY OF TARRANT

KNOW ALL MEN BE THESE PRESENTS:

THAT THE UNDERSIGNED, HEREINAFTER CALLED "PERMITTEE," PURSUANT TO CITY OF FORT WORTH ORDINANCE NO. 7314. COVENANTS AND AGREES TO. AND DOES HEREBY INDEMNIFY. HOLD HARMLESS AND DEFEND THE CITY OF FORT WORTH, ITS OFFICERS, AGENTS, SERVANTS, AND EMPLOYEES, FROM AND AGAINST ANY AND ALL CLAIMS OR SUITS FOR PROPERTY DAMAGE OR LOSS, AND/OR PERSONAL INJURY, INCLUDING DEATH, TO ANY AND ALL PERSONS, OF WHATSOEVER KIND OF CHARACTER, WHETHER REAL OR ASSERTED, ARISING OUT OF OR IN **CONNECTION** WITH. DIRECTLY OR INDIRECTLY, THE PERFORMANCE, **ATTEMPTED** PERFORMANCE. **NON-PERFORMANCE**, OF DEMOLITION **ACTIVITIES** OR UNDER **DEMOLITION/WRECKING PERMIT NO.** , WHETHER OR NOT CAUSED, IN WHOLE OR IN PART, BY THE ALLEGED NEGLIGENCE OF THE OFFICERS, AGENTS, SERVANTS, EMPLOYEES, CONTRACTORS, SUBCONTRACTORS, LICENSEES, OR INVITEES OF THE CITY OF FORT WORTH: AND PERMITTEE HEREBY ASSUMES ALL LIABILITY AND RESPONSIBILITY FOR. ANY AND ALL CLAIMS OR SUITS FOR, PROPERTY DAMAGE OR LOSS AND/OR PERSONAL INJURY, INCLUDING DEATH, TO ANY AND ALL PERSONS OF WHATSOEVER KIND OF CHARACTER, WHETHER REAL OR ASSERTED, ARISING OUT OF OR IN CONNECTION WITH, DIRECTLY OR INDIRECTLY, THE PERFORMANCE, ATTEMPTED PERFORMANCE, OR NON-PERFORMANCE OF **DEMOLITION ACTIVITIES AT** WHETHER OR NOT CAUSED. IN WHOLE OR IN PART. BY THE ALLEGED NEGLIGENCE OF THE OFFICERS. AGENTS. SERVANTS, EMPLOYEES, CONTRACTORS, SUBCONTRACTORS, LICENSEES, OR INVITEES OF THE CITY OF FORT WORTH. PERMITTEE LIKEWISE COVENANTS AND AGREES TO, AND DOES HEREBY INDEMNIFY AND HOLD HARMLESS, THE CITY OF FORT WORTH FROM AND AGAINST ANY AND ALL INJURIES, DAMAGE, OR DESTRUCTION TO CITY OF FORT WORTH PROPERTY ARISING OUT OF OR IN CONNECTION WITH, DIRECTLY OR INDIRECTLY, ALL ACTS OR OMISSIONS OF PERMITTEE, OR **PERMITTEE'S OFFICERS**, AGENTS, **EMPLOYEES**, CONTRACTORS, SUBCONTRACTORS, LICENSEES, OR INVITEES, RELATING TO SUCH DEMOLITION ACTIVITIES, EVEN IF CAUSED, IN WHOLE OR IN PART, BY THE ALLEGED NEGLIGENCE OF OFFICERS, AGENTS, SERVANTS, EMPLOYEES, CONTRACTORS, SUBCONTRACTORS, LICENSEES, OR INVITEES OF THE **CITY OF FORT WORTH.**
