# **GENERAL SUMMARY**

Performs the most complex inspections in a specific trade area to enforce compliance with applicable codes, regulations and ordinances including the adopted Building, Electrical, Plumbing, Mechanical, Energy, Existing Building and Sign Codes and city zoning codes. Performs technical and complex tasks relative to assigned area of responsibility. Ensures work quality and adherence to established policies and procedures.

### **ESSENTIAL DUTIES & RESPONSIBILITIES**

The intent of this job description is to provide a representative summary of the major duties and responsibilities performed by incumbents of this job. Incumbents may be requested to perform job-related tasks other than those specifically presented in this description.

- 1. Inspects industrial, commercial and residential buildings during various stages of construction and remodeling to ensure compliance with applicable codes, ordinances and regulations. Inspects multifunctional buildings, high-rise structures, hospitals and schools. Serves as lead inspector on large/special construction projects.
- 2. Enforces building codes, regulations and ordinances including adopted International Code Conference Building, Electrical, Plumbing, Mechanical, Energy, Existing Building, Sign Codes and city zoning codes. Issues notices for non-compliance and documents actions. Maintains files and reports for possible legal actions.
- 3. Performs technical and complex tasks including consulting with architects, engineers, contractors and citizens to resolve any differences with inspection decisions.
- 4. Checks distances between new and existing structures to ensure compliance with zoning ordinance.
- 5. Assists in establishing methods for providing inspection and enforcement services. Reviews needs with appropriate management staff. Identifies and locates resources.
- 6. Participates in policy and procedure development. Makes recommendations for changes and to improve existing standards and procedures. Serves as code expert and Department representative to appeal boards.
- 7. Assists in setting operational policy for the field operations division and interprets construction codes.
- 8. Assists with training program development and implementation for Combination and Sr. Combination Inspectors. Makes recommendations to ensure accuracy and consistency in application of Building Codes and trains field personnel.

- 9. Performs related duties as required.
- 10. Adheres to assigned work schedule as outlined in the Department and City attendance policies and procedures; ensures all behaviors comply with the City's Personnel Rules and Regulations.

# **WORKING CONDITIONS**

The work environment characteristics described here are representative of those an employee encounters while performing the essential functions of this job. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

Depending on assignment, positions in this class typically require touching, talking, hearing, seeing, grasping, standing, stooping, kneeling, crouching, reaching, walking, repetitive motions, climbing, balancing, pushing, pulling and lifting; depending on assignment. Incumbents may be exposed to moving mechanical parts, odors, dusts, poor ventilation, chemicals, oils, extreme temperatures, inadequate lighting and intense noises.

## PHYSICAL DEMANDS

The physical demands described here are representative of those that must be met by an employee to successfully perform the essential functions of this job. Reasonable accommodations may be made to enable individuals with disabilities to perform the essential functions.

Light Work – Depending on assignment, positions in this class typically exert up to 20 pounds of force occasionally, up to 10 pounds of force frequently, and/or a negligible amount of force constantly having to move objects. If the use of arm and/or leg controls requires exertion of forces greater than that for the Sedentary Work category and the worker sits most of the time, the job is rated Light Work.
