GENERAL SUMMARY

Under general direction, performs law enforcement and crime prevention duties; and conduct criminal investigation.

ESSENTIAL DUTIES & RESPONSIBILITIES

The intent of this job description is to provide a representative summary of the major duties and responsibilities performed by incumbents of this job. Incumbents may be requested to perform job-related tasks other than those specifically presented in this description.

- 1. Must be able to safely perform all the essential duties & responsibilities as required for the Police Officer and all subordinate ranks.
- 2. Patrols an assigned area to ensure law compliance and to investigate suspicious activities, individuals or conditions.
- 3. Apprehends, interrogates and makes arrest of individuals who violate the law and/or ordinance.
- 4. Responds to calls for assistance and provide necessary police protection.
- 5. Performs complete preliminary and follow-up investigations of crimes and crime scenes either independently or as a member of a team.
- 6. Prepares case files, reports and evidence for submitted and the office of District Attorney or City Attorney.
- 7. Interviews witness, victims and complainant; take depositions and/or statements.
- 8. Writes arrest and searches warrants.
- 9. Conducts searches and collects physical evidence.
- 10. Issues traffic citations or warnings; investigates traffic accidents; and directs traffic.
- 11. Performs other related duties as required.
- 12. Adheres to assigned work schedule as outlined in the Department and City attendance policies and procedures; ensures all behaviors comply with the City's Personnel Rules and Regulations.

Other Job Functions:

- 1. Assumes command of an assigned unit in the absence of Police Sergeant.
- 2. Coordinates purchase of equipment, tools, parts and supplies.
- 3. Assists Unit Sergeant with administrative and supervisory duties.
- 4. Compiles and prepare reports.
- 5. Testify in court.
- 6. Serves as negotiator in hostage or barricaded person situations.
- 7. Makes presentations.
- 8. Directs traffic; investigate traffic accidents; issue citations.
- 9. Perform essential job duties of a Police Officer.

MINIMUM JOB REQUIREMENTS

High School diploma or GED and must have completed 12 hours at an institution of higher education with a grade point average of 2.0 on a 4.0 scale.

OTHER REQUIREMENTS

High School diploma or GED, plus four (4) years continuous service as a Police Officer for the City of Fort Worth.

Advancement to the rank of corporal/detective is through competitive examination as mandated in the Local Government Code, Chapter 143. Four (4) years of service in the immediately-preceding rank is required.

Persons assigned to a non-uniformed position holding this rank shall be referred to as a detective.

Licensed as a State of Texas Peace Officer. Valid Texas Operator's Class "C" Driver's License.

Additional requirements, such as required training courses, and pre- or post-promotional educational requirements may be found in the Texas Local Government Code, chapter 143; the Texas Administrative Code, specifically those code provisions authored by the Texas Commission on Law Enforcement; the Local Civil Service Commission Rules, and any applicable labor agreement.

WORKING CONDITIONS

Extensive travel throughout assigned designated patrol area via foot, auto, motorcycle, bicycle or horse; exposure to emotionally stressful, hostile, dangerous, emergency situations and/or condition; indoor/outside working conditions with exposure to extreme variable conditions.
