# **GENERAL SUMMARY**

Under close supervision learns the necessary skills and knowledge required to become a Police Officer; to become familiar with the Rules and Regulations of the Police Department; and performs related work as required.

# **ESSENTIAL DUTIES & RESPONSIBILITIES**

The intent of this job description is to provide a representative summary of the major duties and responsibilities performed by incumbents of this job. Incumbents may be requested to perform job-related tasks other than those specifically presented in this description.

- Attends the Fort Worth Police Training Academy under the rules and regulations established for such attendance by the Training Division of the Police Department and the Texas Commission on Law Enforcement.
- 2. Participates in exercises designed to develop law enforcement skills.
- Attends classes.
- 4. Performs physical skill exercises.
- 5. May be required to operate a motor vehicle.
- 6. Performs other related duties as required.
- Adheres to assigned work schedule as outlined in the Department and City attendance policies and procedures; ensures all behaviors comply with the City's Personnel Rules and Regulations.

#### MINIMUM JOB REQUIREMENTS

- 2. Have a high school equivalency certificate (GED) and completed at least 12 hours at an institution of higher education with at least a 2.0 cumulative total grade point average on a scale; and
- 3. Must be able to speak, read and write the English language.

# SPECIAL REQUIREMENTS

- 1. Must be between ages 21 and 45 years of age by the date of the entry-level test.
- 2. Must be a United States Citizen.
- Must pass a physical ability assessment as prescribed by the Fort Worth Police Department and approved by the Civil Service Commission, showing the applicant is physically capable of performing the essential job functions of a Police Officer.
- 4. Must pass a psychological examination and be declared in writing (by a licensed psychologist or psychiatrist appointed by the Civil Service Commission) to be in satisfactory psychological and emotional health for licensing as a peace officer.
- 5. Incumbent must pass all other minimum standards and special requirements outlined in <a href="The City of Fort Worth Firefighters">The City of Fort Worth Firefighters</a>' and <a href="Police Officers">Police Officers</a>' Civil <a href="Service Rules">Service Rules</a> and <a href="Regulations">Regulations</a> (a.k.a. # **WORKING CONDITIONS**
