ORDER

If the Defendant fails to complete the terms and conditions as stated above, the Court will schedule a revocation hearing for the defendant to show cause why the deferral of guilt should not be revoked. Notice will be sent to the address on record with the Court. If no good cause is shown, the Court will enter an adjudication of guilt and impose sentence. If a judgment of guilty is entered, a conviction will result, and a fine will be assessed in an amount determined by the judge, not exceeding the maximum allowed by law. In addition, the conviction will be reported to the Texas Department of Public Safety.
