- Sets the ratio requirement

 1:15 ratio requirement (safety, quality, proper control and response)

• Effective January 1, 2023, PARD will lower ASP fees to be consistent with NSD. This will result in reduction of revenue collection up to \$280,000 based on non-discounted fees.





- Combined Estimated Expenditures: \$565,000




SDC Field Trips



Mobile Recreation Summer Day Camp

- 7-week free summer program
- Monday Friday, 9:00 am 3:00 pm
- Program held at schools uses local parks
- Swimming lessons held at Wilkerson-Greines Activities Center (Rainwater Foundation grant)

Como Summer Day Camp

- Como Lion's Heart donation
- Allows youth to attend field trips without cost to family

Donations accepted for "Send a Kid to Camp"



FORT WORTH_®

- After School Program at 61% of capacity in FY2022, expected to grow post-pandemic
- PARD and NSD to align fees for same programs
- Summer Day Camp at 84% capacity in FY2022
- 84% of camp registrants went on at least one field trip
- Summer Day Camp 30% received fee assistance
