Submitter Comments: This plan creates three majority Hispanic districts with 68%, 53% & 50% by voting age population. The Plan contains seven majority minority districts (>50%) by total population and five majority minority districts by voting age population.

This plan creates a likely second Hispanic-controlled district, predominantly in the City's south side neighborhoods (District 10).

Map drawers proceeded along the principle that the creation of a second viable Hispanic district is the minimum threshold for a successful redistricting map for the City of Fort Worth.

Notably, this has been achieved here while preserving three functional African-American districts.
