GENERAL SUMMARY

Performs advanced system administration, planning, operations, maintenance, design, support, and implementation for Oracle PeopleSoft/Enterprise Resource Planning (ERP) environments; oversees specialized technical services functions; and provides responsible support to senior management or supervisory staff.

ESSENTIAL DUTIES & RESPONSIBILITIES

The intent of this job description is to provide a representative summary of the major duties and responsibilities performed by incumbents of this job. Incumbents may be requested to perform job-related tasks other than those specifically presented in this description.

1. Enforce defined conceptual and architectural standards regarding solution implementation as dictated by departmental guidelines.
2. Collaborate with Sr. Developers in the development and maintenance of departmental design artifacts denoting the developmental concepts, architectural standards, and design guidelines.
3. Monitors and determines future growth requirements of the applications in areas such as configuration, sizing, server counts, batch processing throughput, and PeopleSoft Architecture; works with other information technology divisions to address application capacity needs.
4. Installs and maintains, updates (PUM images), patches, maintenance, support, troubleshooting, and issues resolution for PeopleSoft Domains.
5. Designs and deploys PeopleSoft supporting applications such as ElasticSearch, Kibana, COBOL, REN Server, nVision, Excel-to-CI, SSRS Reports, SSL Certificates, Appisan/Pathlock, Zena Job Automation, in accordance with departmental design guidelines.
6. Monitors database and application system performance, and determines/plans mitigation steps for identified issues.
7. Designs and maintains the project migration lifecycle including relevant documentation.
8. Administers project migration lifecycle, including continuous improvement processes.
9. Responsible for managing PeopleSoft, SQL Server database instances, comprehensive knowledge of Windows Server administration, and Microsoft Active Directory basic understanding.
10. Manages third-party applications interfacing with PeopleSoft pillars.

11. Performs other related duties as required.
12. Adheres to assigned work schedule as outlined in the Department and City attendance policies and procedures; ensures all behaviors comply with the City's Personnel Rules and Regulations.
