Submitter Comments: This is a 10-District plan for the 2020 Redistricting process. This map considers the cohesion of most Communities-of-interest in single districts, as well as focuses on placing areas of high growth on the "outer-edge" of the City's boundaries, while placing higher populations within the center 4-5 districts that will likely not experience as much growth in the coming 10 years. In addition, the splitting of block group geographies is kept to a minimum. Lastly, the concept of a pinwheel has been applied where multiple districts contain land in the urban core, thus providing a variety of representation to citizens living there, rather than dominating that location with one council seat.
